**Mileage Reimbursement** The University recently released a new mileage reimbursement for personal vehicle use of \$0.405 per mile. The College of Agriculture is keeping the mileage reimbursement for personal vehicle use at \$0.375 per mile until July 1, 2005 when it will become \$0.405 per mile. The Department mileage reimbursement is \$0.375 on 4- and 5-accounts and \$0.27 on departmental 2- and 3-accounts. As of July 1, only the amount on 4-/5-accounts will increase, the departmental accounts will remain at \$0.27. Thirty-one teams from around the nation competed in this annual event. The Kentucky team placed 9th in swine, 4th in sheep, 3rd in beef cattle and 3rd in oral reasons and 4th over-all. Individually, Lindsey Berry was the 3rd high individual over-all, just 2 points out of first. Lindsey placed 18th in sheep, 20th in swine, 5th in beef and 9th in oral reasons. Teammate Rachel Speaks placed 32nd in both sheep and swine, 21 in beef, 29th in oral reasons and was 22nd over-all. Mike Meyers placed 12th in sheep, 28th in beef, 11th in oral reasons and 40th over-all. Cindy Harris was 34th in swine. The team members are all college freshman with Berry and Harris attending Western KY University, Speaks attending Northern KY University and Meyers attending the University of Kentucky. The team was coached by the late Dr. Monty Chappell, Professor of Animal Sciences, and Dr. Ken Culp, III, 4-H Youth Development Specialist.
