Day 1: Flight - Albuquerque, New Mexico

The balloons make the sky become a pallet of multicolored orbs dancing in the cool morning light. Later enjoy an Albuquerque City Tour featuring the Indian Pueblo Cultural Center depicting the history and culture of New Mexico's 19 Native American pueblos. Stop in historic **Old Town** to stroll the historic adobe buildings that house over 150 shops, galleries and restaurants. Also see the icon of Old Town, the San Felipe de Neri Church. Later witness the Balloon **Glow**, where just before dusk burners from hundreds of balloons light up the evening sky.

Day 3: Bandelier - Los Alamos - Santa Fe

This morning travel to **Bandelier National Monument**, best known for mesas, sheer-walled canyons, rock art and ancestral Pueblo dwellings. Next visit the Los Alamos Bradbury Science Museum to learn about the Manhattan Project and the creation of the world's first atomic bomb. Later today arrive in Santa Fe for a three night stay.
