## SCHOLARSHIP AWARD:

A \$1,000 **tuition** scholarship will be awarded on a semester basis beginning in the 2009 Fall Semester. The scholarship will be renewed for subsequent semesters while scholarship funding is available and student eligibility is maintained.

## ELIGIBILITY REQUIREMENTS:

- Applicants must demonstrate financial need and are required to have **submitted a Free Application for Federal Student Aid (FAFSA)** for 2009-2010 with the UK Student Financial Aid office.
- Candidates must be **women ages 25** and over and residents of the U.S.
- Applicants must be in a degree program at the University of Kentucky as full-time, undergraduate students (12 hours or more) in courses scheduled on the Lexington Campus including distance learning sections. The recipient must maintain full-time student status while receiving this award.
- Candidates are required to have completed **between 60 and 90 credit hours** of course work and have a cumulative **UK GPA of 3.0** or better before May 4, 2009. The recipient must maintain a cumulative UK GPA of 3.0 or better while receiving this award.

## DEADLINE:

Completed applications must be received in room 13A Funkhouser Building *before 6:00 p.m.* on Thursday, July 23, 2009. Applications received after the deadline date will not be considered. **An application form is on the back.**

## SELECTION PROCESS:

Applications will be forwarded to the Suburban Woman's Club for final selection. Members will consider: 1) UK cumulative GPA; 2) academic merit and potential; 3) letter, in terms of content and style; and 4) letters of recommendation. Finalists will be required to attend a personal interview. **The decisions of the Suburban Woman's Club are final.**
