NOTES:

The above rates include mandatory fees charged to all students enrolled on the Main Campus and at the Medical Center in accordance with their status as full-time or part-time students. Students taking all of their courses at off-campus locations outside of Fayette County and its contiguous counties may have the fees waived.

The full-time rate is charged to undergraduate and pharmacy students enrolled for 12 credit hours or more, graduate and professional doctoral students enrolled for 9 hours or more, and law students enrolled for 10 hours or more.

Part-time students and four-week and eight-week intersession students are charged on a per-credit hour basis.
