**ABOUT THE SPEAKER**

**Dr. Robert S. DiPaola** is the current Dean of the College of Medicine at UK. Prior to joining UK, he lead research, clinical, educational & administrative activities of an NCI-designated Cancer Center & served as Vice Chancellor of Cancer Programs at Rutgers. He has held local & national leadership positions including chair of the GU Committee of the Eastern Cooperative Oncology Group, including developing clinical trials that have changed standards of care; has been a member of National Cancer Institute review & steering committees; & is current Chair of the NCI/NIH committee for NCI-designated Cancer Center review. He earned his BS & medical degrees at the University of Utah; completed an internship & residency in Internal Medicine at Duke University Medical Center; & completed a Fellowship in Hematology-Oncology at U. Pennsylvania. Dr. DiPaola maintained continuous funding to do research on Drug Resistance in Cancer Therapy, working on studies that support translational clinical trials & investigations into prostate cancer drug resistance. His research efforts including phase I, II, & III clinical trials have impacted national standards of care. His accomplishments in the area of translational research are underscored by grants from the National Institutes of Health, Department of Defense & private foundations, & his publications in the *New England Journal of Medicine*, *Lancet*, *Genes and Development*, *JAMA*, *Cell*, *Clinical Cancer Research* & *Journal of Clinical Oncology*.

**REDUCE TAXES WHEN MAKING CHARITABLE CONTRIBUTION**

(Article based on March 2016 Council on Foundations *IRA Charitable Rollover Issue Paper* and TIAA *Charity Giving Guide* A40136 (Sept. 2017))

Congress passed and signed into permanent law the IRA Charitable Rollover on December 18, 2015. It allows taxpayers age 70 ½ or older to transfer up to \$100,000 annually from their IRA accounts directly to 501(c) (3) charities without first having to recognize the distribution as income. You do not receive a charitable income tax deduction, but the IRA distribution is not included in your taxable income and satisfies any minimum distribution requirement. You are not prevented from taking a distribution in addition to the charitable distribution.

The benefits of this method of making charitable contributions may include:

- Avoiding limits on your deductions;
- Not being pushed into a higher tax bracket;
- Reducing taxes on a greater share of Social Security income or paying a greater share of Medicare premiums.

The IRA Charitable Rollover has proven to be popular with taxpayers since it reduces their tax liability and benefits charities. Donors may not make charitable rollovers to donor-advised funds or support organizations and private foundations. Consequently, this giving tool has not reached its full potential because of the age restriction (70 ½), cap of \$100,000, and limitations on what charities can benefit. Regardless of these limitations, it is a potential tax break that retirees should know about and may want to explore with their tax accountants.

## FELLOWSHIP AWARDEES FOR 2017-2018

*(UKAEF Fellowship Committee: Lee Edgerton, Chair; Tom Mullaney & John Greenway)*

The Fellowship Committee of the Association of Emeriti Faculty has selected the following three students to receive Fellowships from forty-two applicants. You will have a chance to meet them at the February 13, 2018 luncheon when they provide a brief presentation of their research and future aspirations.

**Amanda Bunting** is a PhD candidate in the Department of Sociology. She is highly regarded as a "potential future researcher and teacher." Her dissertation research examines reentry outcomes (e.g., recidivism, recovery supports) among previously incarcerated users of opioids. She has been a teaching assistant in six courses (UK and University of Maryland, Baltimore County) and the instructor for two courses in Sociology (Transylvania University and Community College of Baltimore). In addition, she has assisted Dr. Carrie Oser in SOC 439, a unique course combining UK undergraduate students with 16 students who are incarcerated. Amanda hopes to offer a similar course in the future at a university where she can continue her research interests as well as teach and mentor a diverse group of students.



**Catherine Gooch** is a PhD candidate in English with a focus on African American Literature. Her dissertation explores the Mississippi River's influence and impact on African American literature and art. She has taught four different WRD classes (Writing, Rhetoric and Digital Studies), assisted with one English course at UK, and taught three classes at Cincinnati State Technical and Community College. In addition, she assisted and tutored students in the Xavier University Writing Center. She is described as a person of "quiet Authority"-- when she speaks "her peers lean

in and listen." Grounded in personal experiences, Cate offers a "compelling voice" for students. Her interdisciplinary research, like a flowing river, promises to "reshape our understanding of African-American writing".



**Elizabeth Spencer** is a doctoral student in the College of Communication and Information. Since 2014, while a TA at Pittsburg State University in Kansas and at the University of Kentucky, she has been the instructor of record for eight courses. In 2016 she won the Best Aural/Visual Project Award in the Ethnography division of the National Communication Association. Her research, informed by personal experience as a care-giver, focuses on understanding issues facing family members of Alzheimer's and dementia patients. She is also exploring physicians' cost-of-care conversations and opioid disposal interventions in Appalachia. Her "nuanced understanding of complex communication processes" has allowed her to work at a "micro level" while keeping the big picture in mind. "She has shown the passion to help inspire students to maximize their life opportunities."
