# ABOUT THE SPEAKER (ZOOM MEETING)

AL CROSS is Director of the Institute for Rural Journalism and Community Issues, which helps rural news media define the public agenda in their communities and reports on broader issues that have local impact but few local sources. The Institute is based in the University of Kentucky's School of Journalism and Media, where Cross is a professor in the Extension Title series, meaning that most of his work is directed off campus. He is in the College of Communications and Information and is a member of the College Faculty Council and the University Senate Council.

Cross helped organize the Institute, which has academic partners at 25 universities in 17 states. He became its director in 2004, after more than 26 years as a reporter at The Courier-Journal, the last 15½ as chief political writer. He writes a political column about twice a month for the Louisville newspaper and is a KET election commentator. His awards include the Kentucky Journalism Hall of Fame (2010), the media award of the East Kentucky Leadership Foundation (2006), the media award of the Kentucky Psychological Association (2013), the James Madison First Amendment Award of the Scripps Howard First Amendment Center at UK (2015), and a share of the 1989 Pulitzer Prize won by The Courier-Journal staff for coverage of the nation's deadliest bus and drunk driving crash. He shared an investigative reporting award in the Southern Journalism Awards for a 1987 series on surface mining, including some of the first comprehensive stories on mountaintop-removal mining.

He is often quoted nationally on Kentucky politics and has appeared on PBS's "Washington Week in Review" and other television programs.

#### REMEMBERING DR. ROBERT STRAUS

(Editor's Note: In the Feb. 2020 UKAEF Newsletter, I suggested members acknowledge and share their colleagues' successes in our newsletter. Thank you to Tom Garrity for reminding us that Robert Straus was one of the five-person team assembled by Dean William Willard in 1956 to develop the academic curriculum of the new UK College of Medicine. Dr. Straus founded the UK Dept. of Behavioral Science.)

Dr. Straus's work led to his election to the prestigious Institute of Medicine of the National Academy of Sciences.

It was the spring of 1970 when I first met Bob Straus. I was a medical sociology graduate student at Duke University and was on the job market. One of my Duke faculty observed that the Department of Behavioral Science at the University of Kentucky was expanding its faculty and searching for new faculty with a social science concentration. Bob Straus was the chairman of that department. I wrote to him and was invited to visit his department to interview.

Our first face-to-face contact was interesting. I was to be picked up by Bob at the front door of my motel. I waited for him just inside the front door. He arrived punctually, locked his car, and came in to meet me. As we approached his car, he unlocked the door for me and rounded the car to unlock his door. I reached across and unlocked his door and thought nothing of it. Unwittingly, I had just passed the first test of our encounter. I learned later that Bob used this "test" to observe how the applicant might fit in with the team he hoped to build.

Another characteristic of Bob's leadership was to promote intradepartmental communication among faculty. Hence, our work and collaboration always involved weekly meetings. Some considered these a waste of time but in meetings we learned about the ideas of our colleagues which helped us avoid misunderstandings and promote novel ideas. In the long run, most of us came to appreciate Bob's ways of furthering good collegial understanding.

Bob's vision for medical education led to the inclusion of the important insights from the social and behavioral sciences in the training of U.S. medical students. Bob's ground-breaking plans for systematic coverage of insights from the behavioral sciences led to development of required behavioral content in medical education at UK and required testing in the national medical certification exams.

I loved Bob as a colleague and mentor from the beginning of my career through our retirement years. I am deeply grateful that I was lucky enough in my life to spend much of it in the Department of Medical Behavioral Science that Bob founded. Rest in peace, Bob.
