ABOUT THE SPEAKER

Timothy S. Tracy became Provost at the University of Kentucky on February 23, 2015.

He received his bachelor's degree in pharmacy from Ohio Northern University, his Ph.D. in clinical pharmacy from Purdue University, and completed a postdoctoral fellowship in clinical pharmacology at Indiana University. Prior to entering academia, he practiced in community and hospital settings throughout Ohio. Tracy launched his academic career at West Virginia University, where he rose through the ranks to Full Professor. During his time at West Virginia University, he won six college-wide teaching awards and one university-wide teaching award. Tracy then joined the University of Minnesota where he served as Head of the Department of Experimental and Clinical Pharmacology, Director of the Center for Forecasting Drug Response and Director of Clinical and Translational Research Services. In August 2010, he joined the University of Kentucky as Dean of the College of Pharmacy and from May of 2012 until August of 2013, also as the Interim Provost.

His research and teaching interests deal with pharmacogenetics and their effect on drug metabolism, as well as the larger field of clinical pharmacology. Tracy has published almost 100 scientific manuscripts, more than 15 book chapters and edited two books and has served as a principal and co-investigator on numerous NIH-funded grants.

The Provost is overseeing efforts related to several pressing issues facing the University of Kentucky. Among others, these include:

- Strengthening our work in undergraduate student retention and graduation;
- Strengthening our graduate and professional education efforts;
- Advancing our research enterprise;
- Fostering with greater urgency an inclusive campus environment that celebrates the multitude of backgrounds, identities, and perspectives;
- Further refining and completing our next Strategic Plan;
- Implementing a new financial model; and
- Selecting deans for the colleges of Dentistry, Design, Medicine and Public Health.

NEED SOFTWARE?

The UK Administrative Regulations (2:1-1 section III.C.4 (Emeritus/Emerita Faculty)) specify in part (bold emphasis mine):

"Faculty **employees** with emeritus/emerita status are entitled to the following rights and privileges: to be included in faculty lists in University bulletins and, upon request, to be provided a mailbox in the appropriate educational unit; to be assigned office and/or laboratory space and **furnished supplies for creative work** . . ."

All faculty **employees**, staff **employees**, and students can obtain vital software packages, such as Microsoft Word & Excel, ArcGIS, SPSS, SAS, and virus protection, through download.uky.edu. But when emeriti faculty **employees** try they are greeted with "No software is available to you . . ." When I raised this issue at UK informally I was met with, "Well, that sort of means like paperclips and pencils." I maintain that it means the tools that faculty use to do their work in the 21st century.

My question to UKAEF is, do you want to proceed to obtain the right to software, and, if so, how? One possibility is to insist on all emeriti faculty having the right to download software, which might necessitate UK rewriting some contracts with vendors and paying a bit more money. Another is to recognize that not all emeriti faculty will want such access and to compile a yearly list of those who do for UK purse string holders.
