Plan a visit to International Book Project if you answered "Yes" to either question above. IBP celebrated their 50th anniversary in 2016 in several ways:

- record year of shipping 407,355 books to 61 countries;
- since 1966, books shipments to universities, schools, rural libraries, churches, Peace Corps Volunteers and more in 140 different countries;
- adding books to in-home libraries for refugees, Habitat for Humanity and LFUCG Family Care Center families, and families devastated by tragedies, i.e. Hurricane Harvey in Houston;
- major renovation to warehouse and offices at 1440
   Delaware Ave, 40509—resulting in a welcoming environment for book donors, bookstore patrons and 1000s of volunteers;
- offering books for sale to IBP visitors at nominal cost;
- Community Center space for public to hold meetings of small groups;
- assistance to scholars who wish to downsize their holdings and making their scholarly books/publications available to professionals with similar interests.

The list of accomplishments goes on, beyond what Harriet Van Meter envisioned when she started her small non-profit in her basement in 1966 with the goal of increasing literacy. IBP welcomes your book donations, volunteer hours,

I want to apologize to the board in whose members, I now understand, I created undue angst by waiting until a few weeks before each luncheon to obtain a speaker commitment. Not so with our incoming Program Chair. Dr. Scutchfield has secured the complete schedule already and "the year" hasn't even started! All members are greatly encouraged to participate in, or increase their participation in, AEF's Fellowship Program, which provides financial assistance to UK doctoral students who plan to teach after their graduation. Last year AEF members contributed \$7,395 (164% realized), which combined with funds from our endowment, resulted in AEF being able to provide three fellowships totaling \$7,500.
