LUNCHEON VENUE STUDY

Because many members who attended the April celebration of UKAEF's 20th anniversary expressed a desire to make the Boone Center the base for all AEF luncheons, a committee comprised of Jean Pival, Bill Stober, and Jim Wells was set up to investigate possibilities for our 2009-2010 meetings. In addition to last year's venue, the Equestrian Woods club, the committee was asked to consider the Boone Center, the Campbell House, and the Lansdowne Club.

Although conveniently located, both the Campbell House and the Lansdowne Club lunches proved too pricey--\$30 at the former and \$50-\$55 at the latter. The Equestrian Woods price remained the same as last year, but there were problems with dates and accessibility for most of our members.

Much to our surprise, we learned that the Boone Center had changed management and was very eager to work with us, foregoing monthly membership and the Initiation fees. After much negotiation, our tax exemption status was also acknowledged. The luncheon fee of \$22 is slightly higher than at Equestrian, but the convenience for most of our members and the club's state of the art sound system should make it worth the extra price.

And more importantly, we can now fulfill our organization's original goal of maintaining a close relationship with the UK campus.

MEMBERSHIP RENEWAL

LIMESTONE CROSSING UPDATE

As with Mark Twain's death report, the rumors about the demise of Limestone Crossing have been "greatly exaggerated." While the current state of the economy requires the developers to reposition the community, Limestone Crossing by the University of Kentucky is still viable—adapting to the current economic climate and demands of the marketplace.

The new vision of Limestone Crossing is comprised of several components. The primary component, the state-of-the-art Health Pavilion, will offer assisted living, memory support, skilled nursing and a variety of amenities and programs. In addition, several housing options will be available, i.e., fee-simple single-family homes and rental villas.

The Pavilion will introduce unique, value-centered

membership opportunities for self-sufficient 60+ adults. For example, they will be allowed to reserve access to a private room in the Pavilion in case long-term care should be needed, without being required to leave or sell their current homes. And, as previously planned, the Pavilion will become a U.K.-related Geriatric Center of Excellence with a Geriatrician serving as members' primary-care physician. It will also incorporate substantial common areas and amenities to include a medical clinic, a lifelong-learning program, chef-prepared meals and much more.
