- Three (07%) of all newly endowed chairs are named for women; 22 (50%) are name for men.
- Of the 48 newly endowed chairs that have been created, one (02%) has been awarded to a woman; 12 (25%) have been awarded to men.
- Of the 13 newly endowed chairs that have been filled, one (08%) is occupied by a woman; 12 (92%) are occupied by men.
- 5 times as many endowed professorship are named for men as for women.
- 10 times as many endowed professorships have been awarded to men as to women.
- Of all newly endowed chairs and professorships, 1 in 10 honors a woman.
- Of all newly endowed chairs and professorships, fewer than 1 in 20 has been awarded to a woman.
- Less than 1 in 10 of the newly endowed chairs and professorships is occupied by a woman.

As of 11/2000, approximately a dozen of the endowed chairs had not been named and 75% had not been filled. Similarly, approximately a dozen endowed professorships had not been named and about 3 dozen were not filled.

The Kentucky Council on Postsecondary Education(CPE) does not require the University to report the expenditure and use of Research Challenge Trust Fund (RCTF) monies by either sex or race, and UK does not include either in its own monitoring of RCTF-related activity. The gender-specific nature of human names permitted analysis of endowed chairs and professorship names and occupants of each by sex. Given the data collected by the University, there is no way to even approximate either the race/ethnic origins of the names of the endowed chairs and professorships or the race/ethnicity of their occupants.
