## Recommendation

1. The President should consider an immediate, administrative structural change that creates one central administrative body for the academic units of the entire University.

## Recommendation

2. The President should consider an evaluation of the manner in which resources, both indirect costs and space, are distributed through the Office of the Vice President for Research.

#### Recommendation

3. The President should consider merging the College of Architecture, the Department of Interior Design, and the Department of Landscape Architecture into a new College of Design.

#### Recommendation

4. The President should consider eliminating the College of Human Environmental Sciences. The Futures Committee recommends that the Department of Family Studies join the College of Social Work, that the departments of Hospitality Management and Merchandising join the Gatton College of Business, and that the Department of Nutrition and Food Science join either the College of Agriculture or a unit of the Medical Center.

#### Recommendation

5. The President should consider realigning departments in the College of Arts and Sciences and select other departments and colleges into three new colleges: a College of Science and Mathematics, a College of Social and Behavioral Sciences, and a College of Arts and Letters. The President should consider combining the departments of Physics and Astronomy, Chemistry, Geology, Statistics, Biological Sciences, and Mathematics to form the College of Science and Mathematics.

The President should consider combining the departments of Psychology, Geography, Political Science, Sociology, and Anthropology (from the College of Arts and Sciences), and the College of Communications (except the School of Journalism). The President should invite the faculty from the Department of Economics in the College of Business, the Department of Behavioral Science from the College of Medicine, the Departments of Rural Sociology and Agricultural Economics from the College of Agriculture, the Martin School, and the Patterson School to join the new College of Social and Behavioral Sciences.

The President should consider combining the Departments of English, History, Philosophy, English, Spanish Languages and Literature, French Languages and Literature, German Languages and Literature, Classical Languages and Literatures, the College of Fine Arts, and the School of Journalism to form the College of Arts and Letters. The multidisciplinary programs and associated budgets currently in Arts and Sciences should be examined further to determine whether these programs more appropriately belong to the College of Social and Behavioral Sciences or to the College of Arts and Letters.

#### Recommendation

6. The President should appoint a committee to look carefully at the location of programs now within the College of Allied Health Professions with particular attention to the potential for integrating research and clinical training programs throughout the Medical Center.

### Recommendation

7. The President should appoint a committee of faculty with scholarly credentials and possibly outside consultants to examine the future of the School of Public Health. The committee should identify what, if any, specific, scholarly programs the School of Public Health might enhance and identify the resources necessary to achieve national distinction in such areas.

## Recommendation

8. The President should appoint an academic Committee to revise the Administrative Regulations regarding the reporting relationships of centers and institutes.

9. The President should consider allowing the Graduate Program for Toxicology to remain independent and report to the Dean of the Graduate School.

#### Recommendation

10. The President should consider assigning administrative responsibility and the current recurring funding for the Graduate Center for Nutritional Sciences to the College of Medicine. The Program will remain an independent center.

## Recommendation

- 11. The President should consider implementing the following recommendations designed to establish the reporting relationships of the Director of the Sanders Brown Center on Aging and clarify the reporting relationship of the Gerontology Program.
  - [1] The Sanders Brown Center on Aging will be housed under the umbrella of the College of Medicine. The Director of the Center will

report to the Dean. The Dean is charged with maintaining the multidisciplinary nature of the research program in the Center, welcoming participation by faculty from across the University.

[2] The position of the Director of the Gerontology Program will be abolished. The Director of the Program will become Director of Graduate Studies in the Sanders Brown Center on Aging. The Director of Graduate Studies will report directly to the Director of the Sanders Brown Center on Aging.

#### Recommendation

12. The President should consider assigning administrative responsibility and the current recurring funding for the Graduate Center for Biomedical Engineering to the College of Engineering. The Program will remain an independent center until such time as the College launches an undergraduate program in biomedical engineering, at which time the Center will become a department.

## Recommendation

13. The President should consider allowing the Patterson School to remain independent and report to the Dean of the Graduate School or become part of a new College of Social and Behavioral Sciences. The President, however, should consider the appointment of a Committee to examine the scholarly leadership that might be provided by others in the University of Kentucky community to direct the future of international studies.

#### Recommendation

14. The President should consider allowing the Martin School to remain independent and report to the Dean of the Graduate School or possibly report to a new College of Social and Behavioral Sciences.
