The combination of life experience and education enables these students to synthesize information differently than traditional students and so to increase our enrollment in response to the Nursing shortage, this is a way to move students through more quickly and maintain the integrity of our degree.

NUR 862&864 are being replaced with a combined Pathophysiology/Pharmacology course that allows for better integration of content and application situations. All BSN students will take this sequence of courses.
