The proposed changes in the curriculum involve two modifications: (1) Elimination of the current requirement that students complete one course from the category "Applied course," which reduces the credit hour requirement in the major from 26 hours to 23 hours; and (2) eliminating the currently required Senior Comprehensive Exam from the curriculum.

- 1. Elimination of the current requirement that students complete one course in the category "Applied course," thus reducing the credit hour requirement in the major from 26 hours to 23 hours We will continue to have these courses available to students, but we have decided that requiring a course from this category is unnecessary for our majors. By eliminating this requirement we create a little more freedom for the student to select courses consistent with their interests rather than merely to fulfill a requirement.
- 2. Eliminating the currently required Senior Comprehensive Exam from the curriculum We have been using a 60-item multiple choice exam covering the contents of PSY

215, 216, 311, 312, 313, and 314, which we constructed ourselves, as an assessment tool for graduating majors. However, we have determined that this exam has unacceptable validity as a measure of the quantity or quality of psychological knowledge possessed by our graduating majors. The department will be working toward developing a completely different assessment tool, likely of a completely different format and with different contents. Assessment of graduating majors will then be based on a system which does not require testing every major, but rather only a representative sample. Such an assessment will include quantitative and qualitative indices. Hence, we no longer need it listed as a requirement for all majors.

In addition, the list of Elective Psychology Courses has been expanded.
