## Changes to the PLS BS Degree Core Requirements

### Major Requirements:

Change Major Requirement hours from 31 to 32, and change the hours for PLS 366 from 3 to 4 credit hours.

We have the following Areas of Emphasis in the PLS Major:

Crops and Soils

Crops and Livestock

Horticultural Science

Horticultural Enterprise Management

Plant Pest Management

Soil and Water Environmental Science

Turfgrass Science

The impact of this change in the Major Requirements on these areas of emphasis is on the free electives available. Each of these areas of emphasis has at least 12 hours of free electives. The reduction by one hour in each area results in 11 to 20 hours of free electives, depending on the area.
