We would like to thank Ms. Hayden for the teachable moments arising from her Sept. 17 "Dumb American" column pertaining to several of our U.S. Government students attendance at a recent McCausland City Council meeting.

For the record, all North Scott U.S. Govern-

ment students must attend a local government meeting as a requirement to pass the class. North Scott High School is one of the very few schools in the area that requires observation at the grassroots level. Our goal is to show students that local government is accessible and made up of members of the community. After attending a meeting students must then describe two significant agenda items discussed at the meeting reflecting on how they, as either council members or school board members, would address the items and finally analyze and evaluate the effectiveness of the meeting.

When students in our classes mentioned the column, we read pertinent sections of Ms. Hayden's column to each respective class. The vast majority of students were furious, indignant and felt badly for the students mentioned (but not named) in the column. This, in turn, led to a discussion on freedom of the press versus humiliation of 16- and 17-year-old students.

Should all students know who our governor and lieutenant governor are? Of course. (Should ALL Iowa citizens know? Of course.)

Fact: Students received this assignment just a few classes after the school year began. We suggested they might want to wait a few weeks into the semester for more class content.

Fact: Students were warned that at some meetings they may be asked questions.

Fact: Until the November election, on a round-robin basis, students are reporting on the state gubernatorial and national Senate races. Not only will students know the candidates' names, but more importantly the candidates' respective stances on issues.

Fact: Other students who attended the same meeting easily answered the mayor's questions; however, this was not reported.

Fact: According to our records, of the approximately 85 students who attended a local government meeting spring semester last (academic) year, three attended a McCausland City Council meeting. We are not sure which North Scott area city council meetings Ms. Hayden attends or how many mayors quiz students, but three students is not a wide random sample considering the total number of students, when she wrote, "Every time a new group of kids come to a meeting, they do not know who is the governor of their state."

On a personal basis, we know the students in question. They are great kids who are respectful and would never dream of being rude to adults at a public meeting, or victimize others in a local newspaper column. They are the kinds of students we can count on when needed. They are responsible. They learned these traits from their parents and the North Scott community.

We are grateful to teach in a district where parental involvement drives the character and academic development of their children, our students.

The U.S. Senate race:

What do the Kochs want?

On Sept. 17, a writer stated Joni Ernst received \$25,000 from the Koch brothers and it was the "same money they contribute to all close Senate campaigns."

There are not many families in Iowa that can afford to give \$25,000 to a single candidate, let alone multiple candidates. The money given directly to candidates can be tracked; unfortunately there is a lot more money going into the election cycle than direct contributions to candidates.

In addition to the direct contributions, the Koch brothers and their dark money political network have pledged \$300 million for this election cycle. The Center for Public Integrity reports that Koch linked groups ran nearly 44,000 TV advertisements nationally between 1/1/13 and 8/31/14. To put that in prospective that is 1 out of every 10 TV advertisements in a 20-month period. The Koch Brothers are not just interested in Senate campaigns they have been a major source of funding for House races, state and local candidates, too. There is too much money in politics coming from all directions.

The question I have is just what are they purchasing? What is their agenda? David Koch ran for Vice President on the Libertarian ticket in 1980. I'm sure candidates don't always support everything on their party's platform but many of the items on the Libertarian platform were pretty radical. Some of the platform planks are as follows: repeal of federal campaign finance laws; abolish Medicare and Medicaid: repeal Social Security - pending repeal make Social Security voluntary; oppose all personal and corporate income taxation including capital gains taxes; end government operation, regulation and subsidy of schools and colleges; privatization of public roads and national highway system; and abolish the Environmental Protection Agency.

Most Americans would agree the Libertarian/Republican agenda is too extreme. Even the citizens of the Koch brothers' home state of Kansas are starting to have second thoughts. A few months ago nobody would have predicted there was a chance that Republican Gov. Sam Brownbeck or Republican U.S. Sen. Pat Roberts would be at risk of losing their reelections in the red state of Kansas. While many look at Kansas's \$300 million funding shortfall caused by Brownbeck's massive tax cuts, the increased poverty rates, the cuts in school funding, the cuts in services and say Brownbeck went too far, the Koch Brother supporters say the problem is he just didn't cut enough. Most Americans disagree with the Koch Brother agenda.

Before candidates accept large sums of money from a supporter they should know what that supporter expects in return. The candidate should research what the supporter wanted in the past. If there is a major conflict in the candidate's agenda and supporter's agenda the funds should be declined.

Voters should be able to know who is behind the dark money groups funding advertisements and candidates. If money is speech we ought to who is speaking and what they want.
