After moving to Midway in 2014, the logistics made it impossible for me to be as accessible and available as necessary to effective administer this after-hours ministry, so I delegated to others and only this year fully retired from the ministry.

We have loved and nurtured them as though they were our own (to us, they ARE!!) and been privileged to be an integral part of their lives since they were babies. Only recently, we convinced my 86-year-old Mother to retire from her small W.Va. farm and move into the Midway School Apartments where she continues enjoying a vibrant and independent life enjoying daily interaction with her dear friends and neighbors at the apartment community. Dana and I enjoy our home and close relationships with our friends and neighbors on Mill Road. As with the rest of Midway, this has been a very welcoming and close-knit community and we feel privileged to have been adopted into it.
