SMALL FARM WINERY

KRS 241.010(45)

- **Winery which produces wines in an amount not to exceed fifty thousand (50,000) gallons in one (1) calendar year.**
- **Small farm winery license fee is \$100.00 per year**



SMALL FARM WINERY

KRS 243.155

- **Manufacture and bottle wines produced by the small farm winery.**
- **Bottle wines produced by another small farm winery.**
- **If the small farm winery is located in wet territory, sell wine at retail to consumers by the drink or by the package (bottle) at the premises, and at fairs, festivals, and other similar types of events. Wine sold must be produced by the small farm winery or by another small farm winery.**



SMALL FARM WINERY

- **If the small farm winery is located in wet territory, consume wine on the premises. Wine consumed must be produced by the small farm winery or by another small farm winery .**
- **If the small farm winery is located in wet territory, serve complimentary wine samples not to exceed six (6) ounces per patron per day. Wine served must be produced by the small farm winery.**
- **Sell and transport wine produced by the small farm winery to wholesale license holders and other licensed small farm wineries.**



SMALL FARM WINERY

- **Ship wine produced by the small farm winery to a consumer if: (1) wine is shipped by licensed common carrier; and, (2) wine shipped is limited to two (2) cases per customer.**
- **If located in wet territory, a small farm winery can obtain a restaurant wine license and retail beer license in connection with a restaurant, hotel, inn, bed and breakfast, conference center, or other enterprise which promotes viticulture, enology, and tourism.**



SMALL FARM WINERY OFF- PREMISES RETAIL LICENSE

- **A small farm winery is also authorized to obtain a supplemental off-premises retail license.**
- **The small farm winery off-premises retail license fee is \$25.00 per year.**
- **A small farm winery off-premises retail license authorizes the winery to sell wine at retail to consumers by the drink or by the package (bottle) at the off-premises retail site. Wine sold must be produced at the small farm winery or produced by another licensed small farm winery.**



SMALL FARM WINERY OFF- PREMISES RETAIL LICENSE

- **Serve complimentary wine samples not to exceed six (6) ounces per patron per day. Wine served must be produced by the small farm winery.**



COMPLIMENTARY WINE SAMPLES

- Complimentary wine samples **CANNOT** be to served at fairs, festivals or similar events.
- Complimentary wine samples may **ONLY** be served at the small farm winery or small farm winery off-premises retail site.
- Complimentary samples must be for wine produced by the small farm winery.
