## RESOLUTION FOR THE DESIGNATION OF AN AGENT FOR THE APPLICATION OF FEDERAL EMERGENCY MANAGEMENT ASSISTANCE

<u>Recommendation</u>: that the Board of Trustees approve a Resolution designating the Executive Vice President for Finance and Administration to be the authorized Applicant Agent representative of the University in all public assistance and hazard mitigation matters for the purpose of obtaining federal financial assistance from the Federal Emergency Management Agency (FEMA) and FEMA programs under the Robert T. Stafford Disaster Relief and Emergency Assistance Act.

<u>Background</u>: The attached DESIGNATION OF APPLICANT'S AGENT Resolution must be filed along with additional supporting documentation with the appropriate Commonwealth of Kentucky office in order that the University may recover available and appropriate federal funds from FEMA under the Robert T. Stafford Disaster Relief and Emergency Assistance Act. Kentucky Emergency Management regulations allow a Designated Agent to serve indefinitely, until such time as:

- 1. The person serving as Designated Agent has a change of duties and is no longer responsible for activities relating to a presidentially-declared disaster;
- 2. The Designated Agent is no longer employed by the agency; or
- 3. The appointing authority determines a new Designated Agent should be named.

The DESIGNATION OF APPLICANT'S AGENT Resolution document shall be retained on file in the Legal Office and shall be updated by the Board as needed.
