<u>Recommendation</u>: that the Board of Trustees authorize the Executive Vice President for Finance and Administration to negotiate and execute the following:

A new lease between the University of Kentucky (Hospital) and 2347 Sterlington Road, LLC, 2333 Alumni Park Plaza, Lexington, Kentucky for space located at 2347 Sterlington Road, Lexington, Kentucky, effective August 15, 2005 through June 30, 2010, for the use of 6,644 square feet of office space, at an annual rate of \$108,961.60.
