<u>UK HEALTHCARE PATIENT CARE FACILITY – UPDATE</u> AND AUTHORIZATION CONSOLIDATION

<u>Recommendation</u>: that the Board of Trustees approve the consolidation of several authorized design and infrastructure projects as well as the addition of a project to meet the equipment and furnishing needs of the new UK HealthCare Patient Care Facility Phase 1A which will bring the aggregate authorized project scope to \$450 million.

Background: As the Board was advised at the December 14, 2004, meeting, the UK Hospital has undertaken a major initiative to replace the original 1959 hospital structure in a multi-phased project over an estimated five-year period. The project involves significant levels of planning, programming, and design along with multiple construction activities. In general terms the project involves: a newly constructed parking garage, demolition of an older garage, new roadways, infrastructure capacity and lines, some equipment, and a five-level (counting basement) hospital base (consisting of a major concourse along with various hospital functions and services) topped off with two bed towers of six stories each. It is anticipated that the new hospital building when completed, will be a combination of both shelled and fully fitted-out space. Significant equipment and furnishings will be required prior to occupancy but cannot be fully detailed five years in advance, given the rapidly changing character of health care technology.

The university is well along on programming and preliminary design of the project. This effort is being led by university design and construction professionals, UK HealthCare administration, and a design team headed by the Lexington office of GBBN Architects and the nationally experienced healthcare design firm of Ellerbe Becket Architects. Programming decisions and cost estimating and budgeting have become clearer as the project has progressed. Currently, the entire Phase 1A project will carry a full scope of \$450 million. This amount includes planning, programming, design, construction, major infrastructure needs, and all equipment needed to service the fitted-out space. The project budget also allows for significant additional shelled space to allow the hospital to grow and change over the coming years without the necessity of complicated heavy construction in the midst of a working hospital.
