7. Discussion on formalization of relationship with ASAS

The American Dairy Science Association has SAD (Student Affiliate Division) Block & Bridle is an affiliate of ASAS, but not "officially"

Jeannette Moore was invited to speak at the ASAS Board of Directors' meeting immediately prior to the B&B Advisors' meeting. Jeannette requested that ASAS make B&B more visible by putting the B&B link under the "student info" link instead of the "other links" section on the main ASAS website. The Board thought this would be a good idea.

Discussion ensued about the relationship between B&B and ASAS. The B&B Outstanding Senior has been a part of the ASAS Awards Ceremony for many years, and the top three B&B Outstanding Seniors for each year are listed in the ASAS Awards Program going back to 1974. Block & Bridle has long been considered the student affiliate division of ASAS by many, but this relationship is not a formal one. The question was raised as to whether or not B&B can put "a student affiliate of ASAS" on the B&B website. Jeannette expressed a desire to strengthen the relationship between B&B and ASAS. The ASAS Board of Directors said the relationship will be discussed at their next meeting (in January).

The B&B advisors discussed the changes that have occurred in Animal Science since B&B was formed. Should B&B be changed to include Companion Animals? The general consensus was to "let sleeping dogs lie" and to not change B&B. Many schools have separate Companion Animal clubs; others incorporate companion animals as a subdivision of the Block & Bridle chapter. It was announced that there is a new national horseman's club being formed.

8. Discussion on making the summer advisor meeting be "virtual" instead of "in person"

Fewer advisors can attend the ASAS convention each year, and with budget constraints becoming more prohibitive each year, this trend is likely to continue. The advisors who were present at the meeting all felt the B&B Advisors' meeting is beneficial and expressed a desire to continue with these B&B Advisor meetings at future ASAS conferences. A suggestion was made to put a speaker phone or web link in the room so advisors who could not attend the ASAS meeting would be able to participate in the meeting.

9. Discussion on changing the due date for Outstanding Senior from June 1 to June 15

The due date had been earlier so the top three could be selected and be announced at the summer ASAS meeting. In 2003, ASAS met in June, and it was not possible to announce the top three Outstanding Senior nominations. Now the winners from the past convention are announced at the ASAS award ceremony, and all of the nominees for the current year are announced. This means it is no longer necessary to have the due date for Outstanding Senior be earlier than June 15.

The advisors who were present unanimously supported a change in due date from June 1 to June 15 for the Outstanding Senior nominations. (All other awards and entries are due on June 15.)

10. No other business was announced.
