FOUR FELLOWSHIPS AWARDED

After thorough evaluation and deliberation the Fellowship Committee, comprised of John Greenway, Tom Lillich, and William Green, chose four applicants out of twenty submitted to receive UKAEF Fellowships. All four pledged to teach at the University level.

Colleen Glenn, English. Colleen is in the fifth year of her doctoral program with a concentration in American Studies. Her dissertation topic deals with combat fatigue and the indirect representation of war trauma in Hollywood films of the fifties. She spent two years in the Peace Corps as a teacher of English in Romania. At UK, she has taught composition, major Black writers, and Intro to Film.

Kevin Kehrberg, Music/Musicology. In the fourth year of his doctoral program in Musicology, his dissertation topic entails the first scholarly examination of the music and life of Alfred E. Brumley, one of the most important American gospel hymn composers of the twentieth century. His teaching experience includes courses at UK, an adjunct faculty member at Transylvania, and a research fellow at Berea College.

Erin Militzer, Mathematics. The fifth year doctoral student's dissertation is in the area of complex analysis. She has taught several courses at UK and has
