ABOUT THE SPEAKER

Merlene Davis is a native Kentuckian and graduate of the University of Kentucky. She worked in journalism for nearly 34 years, the last 31 at the Lexington Herald-Leader. She began her career as a general assignment reporter at the Memphis Press-Scimitar in Memphis, Tennessee, and then moved to the Herald-Leader when the Press-Scimitar folded in 1983. She has written about Fayette County Public Schools, the local government, state and national issues, racism, inequities at all levels and the need for all of us to find our true selves by unflinchingly looking in the mirror.

Lexington Mayor Jim Gray said, "Whenever Merlene writes a column, she throws a big part of her heart into it. And with that heart comes passion that burns with impatience ... a passion that speaks out for justice, freedom and equality. She calls it like she sees it. ... She's blunt, impatient and even downright pushy. I know. I've been the object of her pen! Reading a Merlene column can tug at your heart-strings or make you really angry or feel like a trip to the woodshed."

She has won numerous awards over the years, but the two most meaningful recognitions were the Lauren K. Weinberg Humanitarian Award in 2012, and being inducted into the Kentucky Civil Rights Hall of Fame in 2014.

She is married with three children and she gleefully retired in May. Now she is trying to figure out what her next move should be.

CHANGES IN RETIREE MEDICAL INSURANCE CARVEOUT FOR 2016

There are a couple changes in the retiree medical insurance carveout for 2016: the rates are increasing slightly and the prescription benefit is changing for some folks.

The rates are increasing 2% for 2016, going from \$302/month to \$308. Currently the retiree with the credit pays \$30 and the increase will be \$1.00/month to \$31/month. The University will cover the remainder of the increase. The spouse rate will increase from \$302 to \$308/month. Complete details of the rate change will come in a mailing from Joey Payne in October.

The change to the coverage of the Medicare Rx Pharmacy benefit for 2016 deals with Tier 3. Previously Tier 3, Non-Preferred Brand medications were covered at 50% coinsurance with no maximum copay. For 2016, Tier 3 Non-Preferred Medications will no longer be covered. All Tier 3 Non-Preferred Brand medications will have a covered alternative in Tier 1 or Tier 2. Should a UK Medicare retiree have documented medical need for a Tier 3 Non-Preferred medication there is a provision to seek coverage through a Prior Authorization process. Complete details of the 2016 UK Medicare Rx Prescription Benefit will be coming in a mailing from Express Scripts in October.

HELP CLOSE ACHIEVEMENT GAP

Big Brothers Big Sisters of the Bluegrass implemented an academic version of its traditional mentoring program in September 2015, made possible by Kentucky Bank, Urban County Government and an anonymous donor. Their goal is to help students at William Wells Brown Elementary School raise their test scores. BBBS's national Schools Plus Program matches volunteers with a child at the school about an hour each week. Academic mentors and second grade students are paired for two years. With this increased individualized attention, the program's goal is to boost children who are presently classified as novice to test proficient in the state's accountability system.

IN CASE YOU MISSED UK STATS FOR FALL 2015--

President Eli Capilouto continues to emphasize UK Students' successes, now and in their futures. He wants UK to be a 1st-choice university for the best students, faculty and staff. Enrollment highlights for Fall 2015 at UK include:

- the1st-year class numbers 5,217, a 21% increase since 2010;
- 25.5 average ACT for 1st-year students; 117 are National Merit, Hispanic and Achievement Scholars; 700 had ACT/SAT scores of 31 or above;
- 1st-to-2nd-year retention was 82.7% last year; 6-year graduation rate was 61%.

In the past 4 years, UK initiated or will begin \$1.8 billion in capital construction projects focused on living, learning and dining spaces, classroom and research facilities. UK Administrators and Board of Trustees will update the UK Strategic Plan during their Oct. 2015 retreat, emphasizing increased retention and graduation rates and creating an environment that prepares students to compete and lead in a global economy as well as helping Kentucky with the workforce it needs to thrive in the 21st century.
