#### ABOUT THE SPEAKER

Stephen Voss is a Louisiana native who began his involvement with electoral politics as a journalist, in which capacity he worked at the 1988 Republican National Convention in New Orleans and also spent two years as a statehouse reporter in Baton Rouge. He ended his reportorial career with Gannett News Service and USA Today by covering the political emergence of former Klansman David Duke. Voss carried that interest in voting and elections – not to mention race, ethnicity, and culture – over to his academic career. He earned a doctorate in Government from Harvard University, working with the eminent quantitative analyst Gary King, and has published a series of research articles related to electoral topics, including congressional districting, racial politics in the South, and, more recently, Kentucky politics. His election commentary appears frequently in local, state, national, and even international media outlets. In fact, the university's public-relations office estimated that UK was mentioned more than a thousand times in 2014 political news as a result of Voss's outreach efforts
