Dear Colleagues

We are so looking forward to another excellent and productive year for the University of Kentucky Emeriti Faculty Association. The UKAEF Board has been working hard to address many issues. Tom Mullaney, Fellowship Chair and the Board wish to extend a sincere THANK YOU to our members who continue to contribute every year to our fellowship fund. We want to emphasize that 100% of every dollar contributed goes toward the fellowships with no overhead and is fully tax deductible. Jim Chapman, our Treasurer shared that our members donated \$4,205 to the Fellowship account this past year. Let's exceed this goal! Our invitation for you to donate is found on the dues renewal form, a separate letter insert in this newsletter. We deeply appreciate any gift.

Speaking of dues, we need your help to recruit new members so we can reach our goal of 235 members for 2016-17. Jim Chapman manages our accounts closely and plans each year's budget carefully. We need revenue generated from 235 dues-paying members to meet our organization's operating expenses this year. We are currently strong financially and wish to keep it that way. I appreciate your help. Word of mouth seems to work best in recruitment—at least that is my experience.
