GIFFORD BLYTON: 1908-2010

Gifford Blyton, one of the five founders of the UKAEF, was the author of the organization's by-laws, served as its first president, and was chair of the Legislative Committee for several years. As a professor of Speech, he initiated in 1948 a debate program, that had by 1969 garnered over 700 trophies. Well into his 90's, he served as parliamentarian for the UK Senate.
