

2018-19 Calendar of Senate, Board, and CPE Meeting Dates

(NEW PROGRAMS MUST BE APPROVED BY SENATE BY MARCH 18, 2019 TO BE EFFECTIVE FOR FALL 2019)

The curricular approval process begins with approval of a proposal by the faculty of a department or school. Upon approval there, the proposal is then voted on by college-level faculty. The dean's office sends all college-approved proposals to the appropriate academic council (Undergraduate Council, Graduate Council, or Health Care Colleges Council). The academic council will send notice of approved items to the Senate Council office, which will send new programs to the Senate's Academic Programs Committee (SAPC) for review (not shown on table below); that review can take as little as two weeks for a well-prepared proposal. (Proposals that require more work will be reviewed as quickly as possible; the timeline largely depends on the contact person's responsiveness.) After review by the SAPC, the item will be placed on Senate Council and University Senate meeting agendas. After approval by Senate, a new degree program proposal needs to be reviewed and approved by UK's Board of Trustees and by Kentucky's Council on Postsecondary Education.

- Proposals received **before February 11** will be processed as quickly as possible and will likely have an effective date of **fall 2019**.
- Proposals received **after February 11** will be processed as quickly as possible and will likely have an effective date of **fall 2020**.
