In compliance with KRS 164.250, I am pleased to provide you with the 2003-2004 Fact Booklet, a compendium of current facts about the people and programs at the University of Kentucky. The fact booklet contains statistics on enrollments, retention, research expenditures, faculty salaries, and many other items of interest to our stakeholders and the general public. Also included is a summary of the 2003-2004 Operating Budget.

During the past year, the University of Kentucky has established ambitious goals in its quest to become one of the 20 best public research universities in the nation. In June 2003, the Board of Trustees approved the University's new strategic plan—*The Dream & the Challenge*. The new blueprint will guide the institution's strategic initiatives for a three-year period. The relatively short timeframe will enable faculty, staff and administrators to respond flexibly to the demands of a rapidly changing global environment.

One of our most important strategic goals is to attract and graduate outstanding students. Last fall, over one-third of our freshman class presented a high school GPA of 3.8 or higher. The number of Governor's Scholars enrolled at the University has tripled since 2000. And this year's graduation rate increased for the sixth consecutive year and set a new university record.

The University of Kentucky's research efforts have expanded considerably since the passage of the Postsecondary Education Improvement Act commonly referred to as "House Bill 1" in 1997. With intensive, focused effort and support from the Council on Postsecondary Education's Research Challenge Trust Funds, total research and development expenditures increased from \$161 million in 1998 to \$236 million in 2002, a 47 percent increase. The university is currently ranked 36th among public institutions in total research and development expenditures, up from 46th in 1997.

One of our great concerns is our ability to provide competitive salaries to attract and retain distinguished faculty. In 2002-03, the average salary paid to our faculty was the lowest of our benchmark institutions. We simply must find ways to increase faculty salaries even during these difficult fiscal times.

To provide the space needed for our teaching, research and service programs, several new facilities are now under construction—the Biomedical/Biological Sciences Research Building, the Linda and Jack Gill Building, the Center for Pharmaceutical Science and Technology, and the UK Center for Rural Health. In addition, the University's first new residence halls in 30 years are under construction and expected to accommodate students by fall 2005. Reconstruction of the Main Building continues in the aftermath of the devastating fire in 2001.

I have previously noted that national recognition is not an end in itself; rather, it is a product of excellence in fulfilling our mission and serving the Commonwealth. The University of Kentucky is committed to discovering, sharing and applying new knowledge to improve the lives of those living in Kentucky and the world outside our borders.

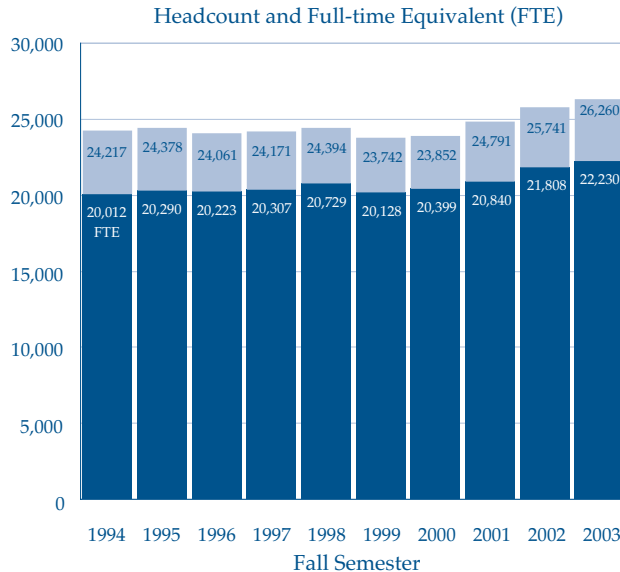

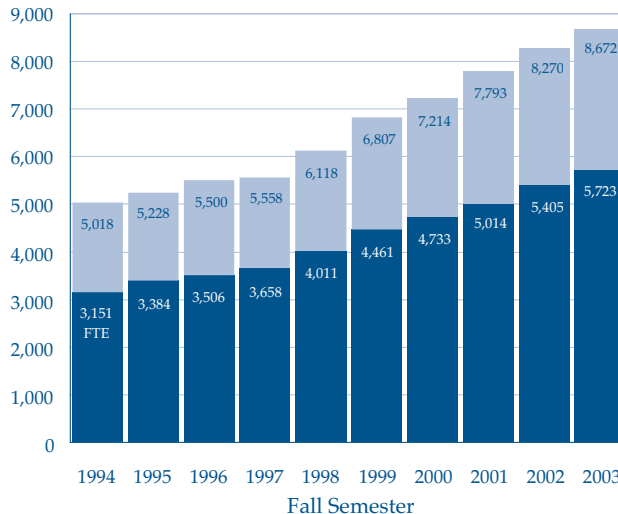
ENROLLMENT - Lexington Community College

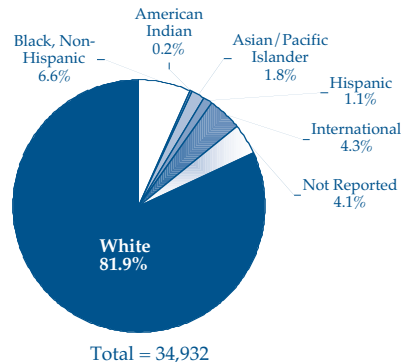

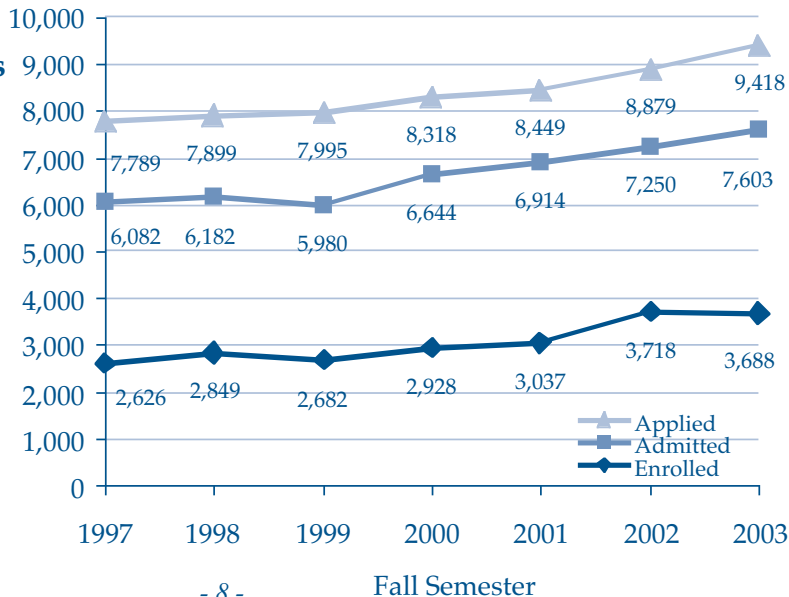

UK First-year Students Fall 2003

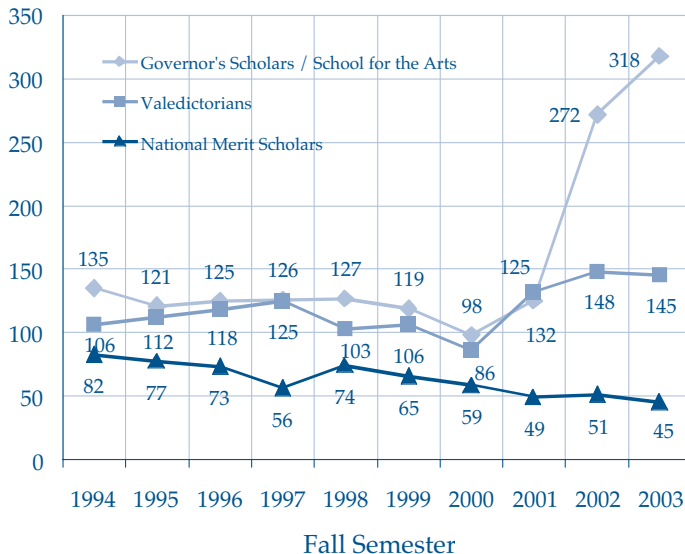
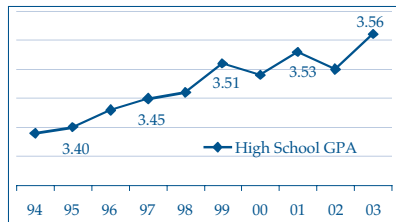

- 45 National Merit Scholars



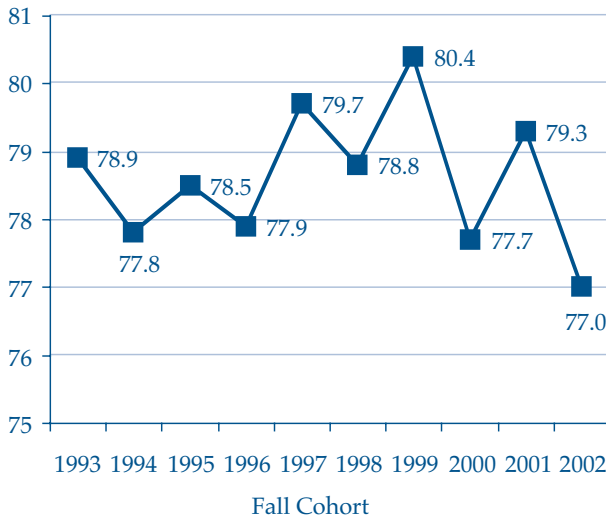

First-to-second Year Overall Retention Rate



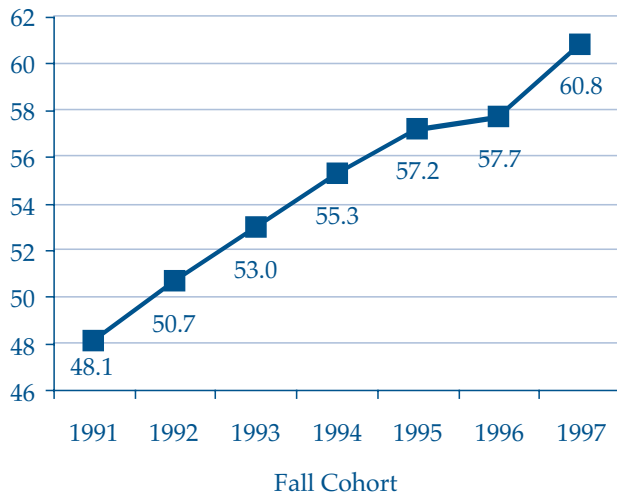

Six-year Overall Graduation Rate

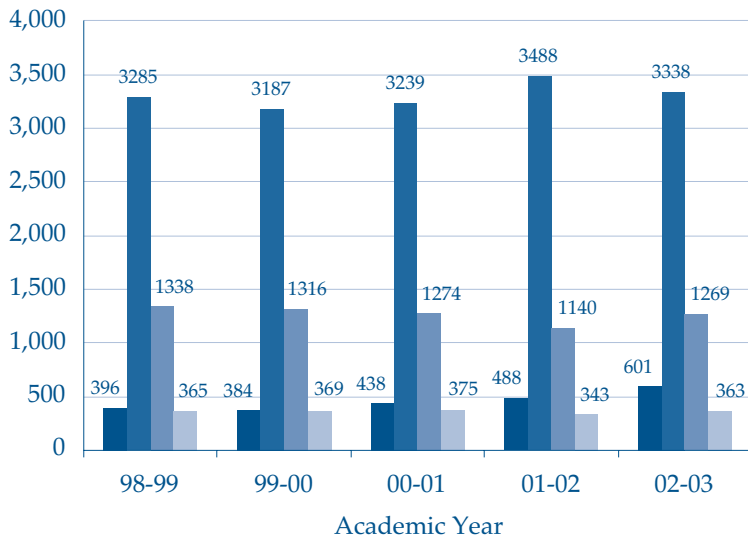

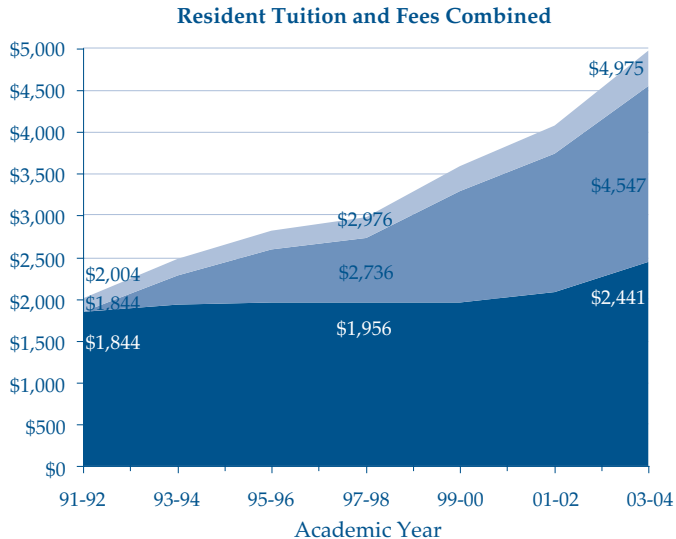

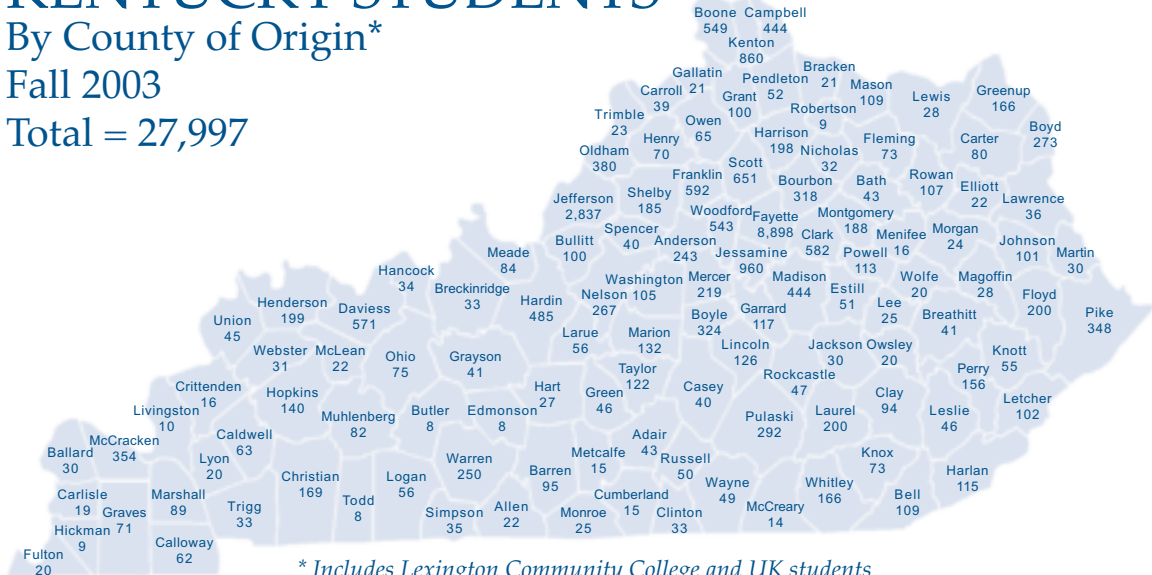


KENTUCKY STUDENTS

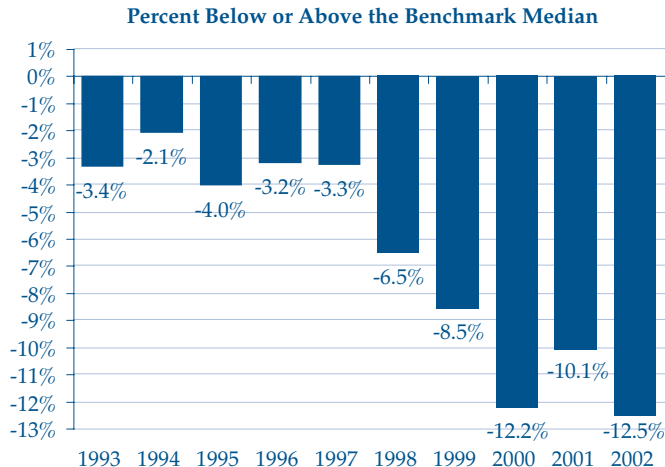

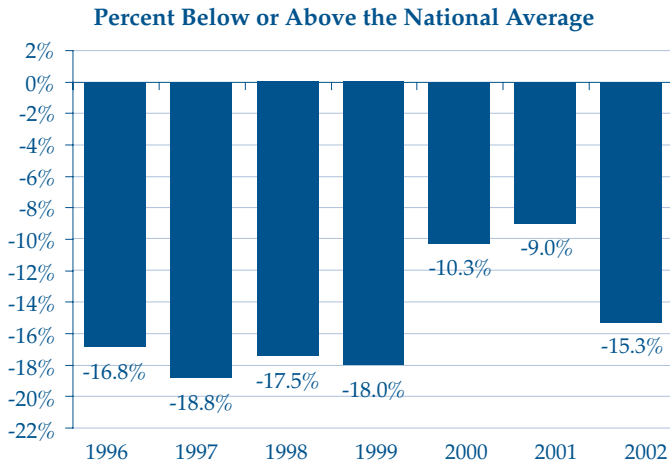

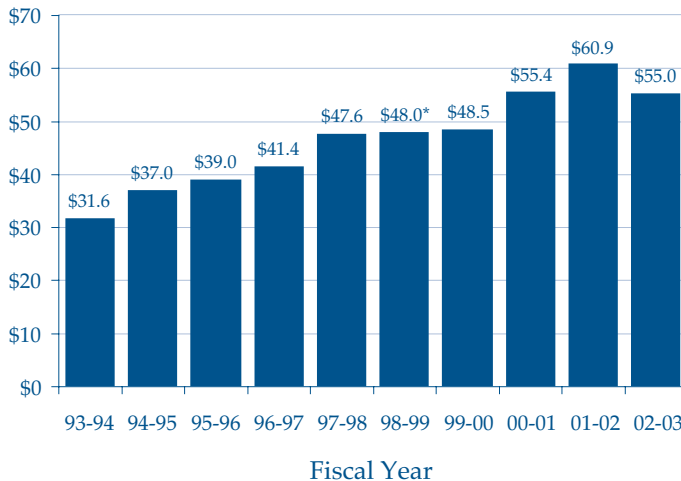

GRANT and CONTRACT AWARDS (In Millions)

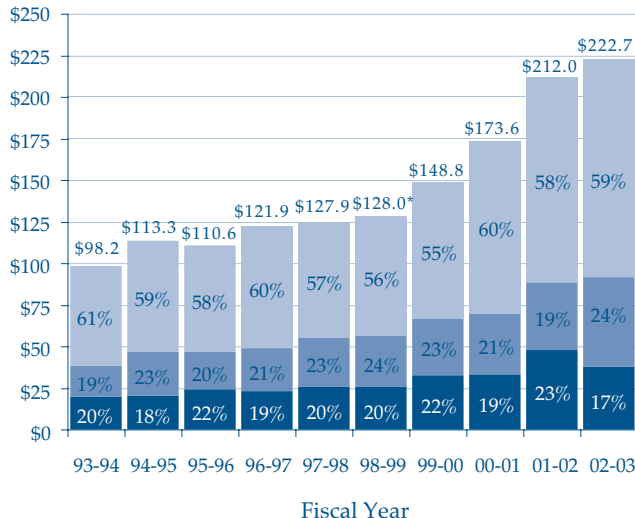

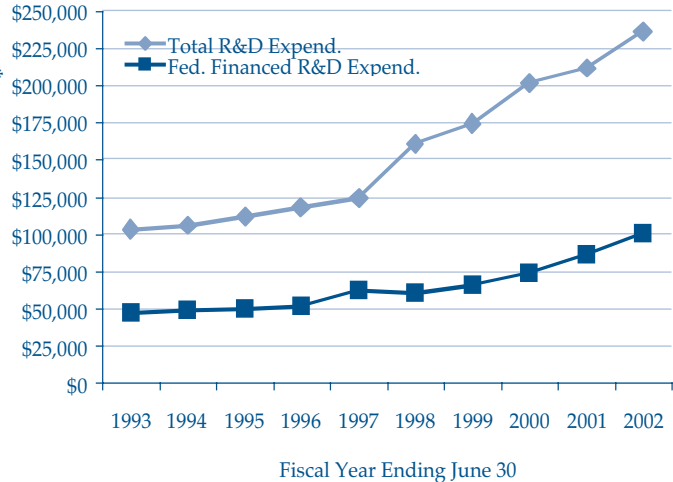

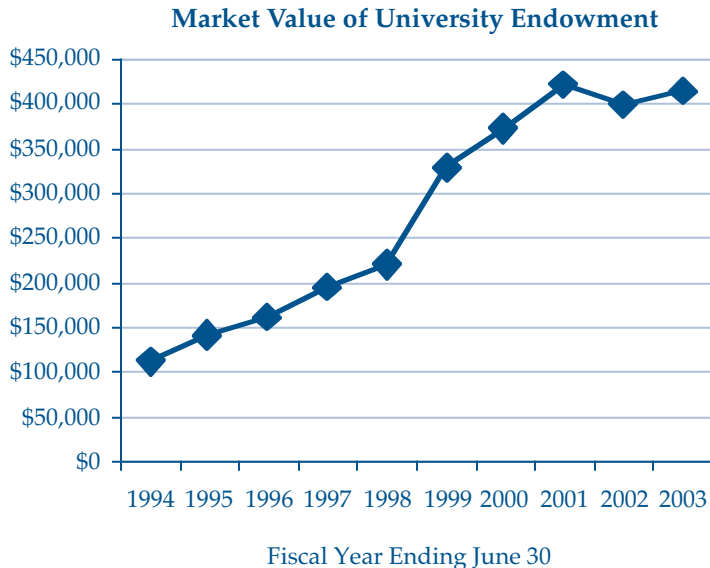

Research and Development Expenditures

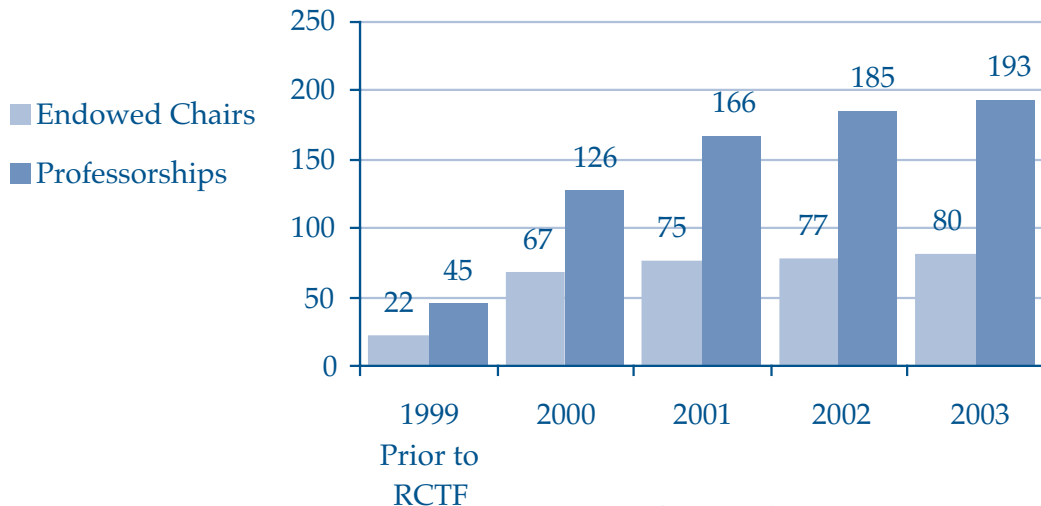

In addition to the above, the Library's collections include 236,754 maps; 5,750 Oral History program interviews; 226 current state, national and international newspapers; the University Archives and Records Program; Audio-visual Archives; the Wendell H. Ford Research Center and Public Archives; the Bert T. Combs Appalachian Collection, including the Appalachian Regional Commission Archives; and the W. Hugh Peal Collection of 19th century English and related literature. The library is a regional depository for U.S. government publications and is also a depository for European Communities and Canadian publications, British Parliamentary Papers, Kentucky government publications, and technical reports from federal agencies, all selectively collected. Numerous CD ROM and online databases are accessible in the main and branch libraries. Library sites include the William T. Young Library and 15 branch libraries. The Voyager library system provides an online catalog for the holdings of all university libraries.

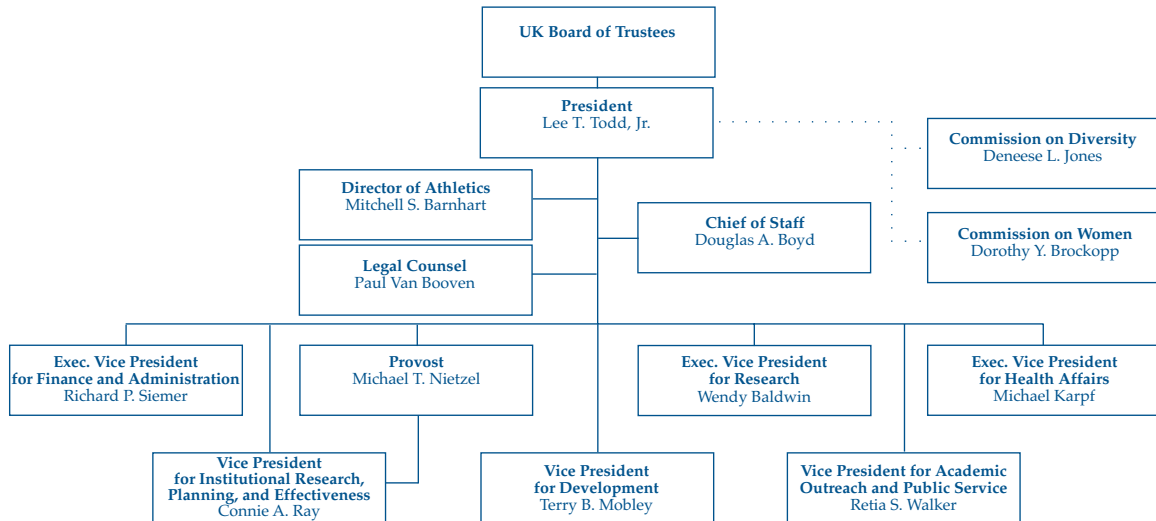

Research Highlights

- UK researchers brought in a record \$222.7 million in outside funding for grants and contracts in FY 03, a 74 percent increase since 1997.
- Research grants and contracts from out-of-state sources accounted for a total 7,633 jobs in the Commonwealth—5,825 jobs at UK and additional jobs throughout the state due to spending from supported research activities.
- UK has 267 active patents, primarily in pharmaceuticals, plant biotechnology, and biomedical engineering; 27 patents were issued in FY 03.
