Abstract Submissions Guidelines for Podium and Poster Presentations

What type of abstracts does University of Kentucky Research Papers Day (UKNRPD) accept?

- We accept completed research as well as theoretical, conceptual and methodological projects to colleagues.
- Abstracts selected for presentation do NOT include concept analysis, systematic reviews, critical analysis, literature reviews or reviews of any kind. However, these can be submitted as posters.

FAQs

1. Is there a cost to submit abstracts? No, just follow the directions for submission and submit your abstract. Registration information will be communicated at a later date. Primary presenters (one per abstract) whose abstracts are accepted will receive free registration for the conference.
2. How many abstracts can I submit? Each person may submit as many abstracts as they want.
3. Can someone else submit abstracts for me? No, you must submit your own abstracts.
4. Is there a word limit? Yes, each abstract is limited to 325 words.
5. Can I make edits to my abstract after the submission site closes? No, you cannot make any edits to your abstract, authors, etc. after the submission site closes. You must enter all information exactly as you wish it to appear in the program. Please include complete information for additional authors, including institution and credentials. Author information (institution and credentials) will be used for the abstract information listed in the program (onsite and online). Please check your abstract, title and author information carefully.
6. How do I know if my abstract gets accepted? You will be notified by email and you will have to send an acceptance email back to say that will be presenting. *Note that if your abstract is declined as a podium presentation it could still be accepted as a poster.
7. All communications regarding the abstract will be sent to the lead author.
8. The lead author is responsible for communicating all information to additional authors.
9. Email your completed abstract registration form to nrpd.abstract@uky.edu
10. Each lead author associated with the presentation must submit biographical data form with abstract registration form and abstract (CV form is at the end of this document) to nrpd.abstract@uky.edu
11. If you get accepted to present, you will be sent a conflict of interest/disclosure form to complete and return.

****Submissions which do not follow submission guidelines will be disqualified.***
