

## Timeline

### UK Administrative Regulation 6:2 and Federal Interpretive Guidance

**1/26/2009** – UK adopted its first Policy on Sexual Assault, Stalking, and Relationship Violence, as [Administrative Regulation \(AR\) 6:2](#).

**2/2011** – U.S. Department of Education, Office of Postsecondary Education published [The Handbook for Campus Safety and Security Reporting, 2011 Edition](#).

**4/4/2011** – U.S. Department of Education, Office of Civil Rights, issued [Dear Colleague Letter](#) regarding an institution's responsibility to respond promptly and effectively to sexual violence in accordance with the requirements of Title IX and [Know Your Rights](#).

**3/7/2013** – President Obama signed the Federal [Violence Against Women Reauthorization Act of 2013 \(VAWA\)](#). Among other provisions, VAWA amended the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act (Clery Act).

**9/30/2014** – UK adopted revisions to AR 6:2 as an [Interim Regulation](#) for compliance with the 4/4/2011 Dear Colleague Letter, and VAWA.

**12/3/2014** – UK adopted final revisions to [AR 6:2](#) to replace the 9/30/2014 Interim AR.

**4/29/2014** – U.S. Department of Education, Office of Civil Rights, published [Questions and Answers on Title IX and Sexual Violence](#) to further clarify legal requirements under Title IX articulated in the April 4, 2011 Dear Colleague Letter and published [Know Your Rights on Title IX and Sexual Violence](#).

**10/20/2014** – U.S. Department of Education published [final regulations](#) to implement the amendments to the Clery Act made by VAWA, to take effect July 1, 2015.

**4/24/2015** – U.S. Department of Education, Office of Civil Rights, issued [Dear Colleague Letter](#) regarding the requirement for institutions of higher education to designate a Title IX Coordinator(s) and published [Title IX Resource Guide](#).

**6/19/2015** – UK adopted new procedures, as an [AR 6:2](#), for responding to allegations of prohibited conduct.

**7/1/2015** – U.S. Department of Education final regulations implementing the amendments to the Clery Act made by VAWA went into effect.

**7/22/2015** – U.S. Department of Education, Office of Postsecondary Education, issued [Dear Colleague Letter](#) summarizing the final regulations

**2016** – U.S. Department of Education, Office of Postsecondary Education published [The Handbook for Campus Safety and Security Reporting, 2016 Edition](#), which replaced the 2011 version and includes information on how institutions can comply with the changes the Violence Against Women Reauthorization Act of 2013 made to the Clery Act.

**6/10/2016** – UK adopted revisions to [AR 6:2](#) and the procedures Appendix.
