ACCEPTANCE OF INTERIM FINANCIAL REPORT FOR THE THREE MONTHS ENDED SEPTEMBER 30, 2021

<u>Recommendation</u>: that the Board of Trustees accept the University of Kentucky consolidated financial report for the three months ended September 30, 2021.

<u>Background</u>: The consolidated financial report includes the financial activities of the University of Kentucky and its affiliated corporations:

- University of Kentucky Research Foundation
- University of Kentucky Gluck Equine Research Foundation, Inc.
- University of Kentucky Humanities Foundation, Inc.
- University of Kentucky Mining Engineering Foundation, Inc.
- Central Kentucky Management Services, Inc.
- Beyond Blue Corporation

As of September 30, 2021, the university has recognized \$1,416,469,169 of current funds revenue representing 28 percent of the 2021-22 approved budget of \$5,078,502,700. Expenses and transfers total \$1,193,612,110 or 24 percent of the approved budget.
