## ACCEPTANCE OF INTERIM FINANCIAL REPORT FOR THE THREE MONTHS ENDED SEPTEMBER 30, 2015

<u>Recommendation</u>: that the Board of Trustees accept the University of Kentucky consolidated financial report for the three months ended September 30, 2015.

<u>Background</u>: The consolidated financial report includes the financial activities of the University of Kentucky and its affiliated corporations:

- University of Kentucky Research Foundation
- The Fund for Advancement of Education and Research in the University of Kentucky Medical Center
- University of Kentucky Gluck Equine Research Foundation, Inc.
- University of Kentucky Humanities Foundation, Inc.
- University of Kentucky Mining Engineering Foundation, Inc.
- University of Kentucky Center on Aging Foundation, Inc.
- Central Kentucky Management Services, Inc.

As of September 30, 2015, the University has recognized \$941,690,091 of current funds revenue representing 28 percent of the 2015-16 approved budget of \$3,368,391,200. Expenses and transfers total \$791,376,067 or 23 percent of the approved budget.
