The Endowment Match Program, also known as 'Bucks for Brains', is one of several programs created as part of the trust fund.



Leading the UK crusade to fight cancer

Spearheading the University of Kentucky's fight against cancer is **B. Mark Evers** (McDowell Cancer Foundation Chair in the Lucille P. Markey Cancer Center). The UK Markey Cancer Center is Kentucky's only National Cancer Institute designated cancer center. Evers leads a team of more than 250 researchers from 11 of UK's 16 colleges, conducting cancer research across the spectrum — from understanding molecular changes that allow cancer to spread, to testing new therapies through clinical trials, to working with community partners to increase cancer screening and save lives.

More than half of Markey's research projects focus on cancers that are high-priority areas due to their prevalence in Kentucky, especially the Appalachian region, including lung, colorectal and cervical cancers. To combat the prevalence of lung cancer, UK's Lung Cancer Screening Program is working to help Kentuckians have a better chance of fighting the disease. Kentucky now ranks 2nd in the nation for lung cancer screening rates. Kentucky has screened approximately 5,000 more people every year over the past three years. Lung cancer screening is key to early diagnosis, and early diagnosis saves lives.

Through collaboration with nearly 20 community hospitals, the UK Markey Cancer Center Affiliate Program extends the center's reach to the farthest parts of the Commonwealth, creating a web of access and excellent cancer care for Kentuckians.

Evers was elected to the National Academy of Medicine in 2020 and has been continuously funded by the National Institutes of Health for more than 30 years. He is a renowned expert on gastrointestinal hormones (e.g., neurotensin) and their role in cancer development as well as in metabolic syndromes. Evers also leads the Cancer Research Priority Area, one of eight designated Research Priority Areas at UK, to continue to push for innovative research in an area that touches the lives of so many Kentuckians.

Using data to interpret Kentucky's profound challenges

Pamela Hull (William Stamps Farish Fund Chair in Cancer Research) plays a pivotal role in enhancing cancer data accessibility and community-driven action. As Associate Director of Population Science and Community Impact at the Markey Cancer Center, Hull introduced "Cancer InFocus: Kentucky," an innovative online mapping tool that combines cancer data with demographics and health determinants. This platform empowers users to strategically address Kentucky's profound cancer challenges, outlined in the Kentucky Cancer Needs Assessment. Hull's vision extends beyond Kentucky as she leads efforts to shift the narrative of cancer through data-informed initiatives, strategic planning and community engagement.

Principal investigator of Lung Cancer Research Initiative

Susanne Arnold (Buck-Kentucky Lung Cancer Research Chair) is an oncologist at the UK Markey Cancer Center, Associate Director of Clinical Translation, eighth-generation Kentuckian and second-generation doctor at UK HealthCare. Her focus is on advancing the science behind cancer treatment through Phase I clinical trials. Arnold specializes in lung cancer as well as cancer of the head and neck. As the principal investigator of the Lung Cancer Research Initiative, funded by the Department of Defense, and the Marty Driesler Lung Cancer Project, funded by the Health Resources & Services Administration (HRSA) and Centers for Disease Control and Prevention (CDC), she has collaborated extensively with other clinicians, epidemiologists, behavioral and basic scientists, utilizing cancer registry data and field research in Appalachian communities to study populations at high risk of developing lung cancer. She has 28 active research projects funded by industry sponsors, the National Institutes of Health and the Kentucky Lung Cancer Research Fund.

Groundbreaking discoveries


Daret St. Clair (James Graham Brown Foundation Endowed Chair) is one of UK's internationally renowned experts in the field of cancer and mitochondria. Her groundbreaking discovery on the role of manganese superoxide dismutase (MnSOD) in cancer development and therapy answered long-debated questions in the field of cancer research. Kentucky has disproportionately high incidences of both cancer and metabolic disorders and leads the nation in cancer deaths and obesity rates.



Binhua Zhou

St. Clair is the co-director of the Center for Cancer and Metabolism Research, funded by an \$11.2 million NIH Center of Biomedical Research Excellence (COBRE) grant. The center funds leading-edge research of early-career scientists, to train the next generation of researchers in cancer cell metabolism. **Binhua "Peter" Zhou** (Made-

line F. James and Edith D. Gardner Chair in Cancer Research), serves as co-director of the Center for Cancer and Metabolism Research. He focuses on understanding cancer on a molecular level – how it forms, breaks apart and spreads through the body. Zhou is also the director of the Breast Cancer Research Program and has had breakthroughs in his research on



triple-negative breast cancer. Zhou continues to dedicate his work to searching for therapeutic targets to prevent cancer from spreading.

Uncovering the potential of a lung cancer treatment

Vivek Rangnekar (Alfred M. Cohen M.D. Chair in Oncology Research Endowment) has made significant strides in lung cancer treatment and obesity prevention. His research team uncovered the potential of the FDA-approved drug crizotinib (Xalkori) to combat the most common form of non-small cell lung cancer. This discovery holds promise for patients seeking an alternative when standard therapies fail. Rangnekar's work with the tumor suppressor protein Par-4 has revealed its dual role in halting cancer growth and preventing obesity, and his multidisciplinary collaborations continue to drive impactful health breakthroughs.



Working to understand life-threatening heart conditions



Alan Daugherty

Alan Daugherty (Gill Foundation Chair in Preventive Cardiology), director of the Saha Cardiovascular Research Center and Saha Aortic Center, co-leader of the Cardiovascular Diseases Research Priority Area and Chair of Physiology in the College of Medicine, is working to better understand life-threatening heart conditions and ways to treat them to save Kentucky lives. Thanks to a \$1 million award from the American Heart Association, Daugherty is studying ways to repair damaged aortas (the body's main artery) with medication rather than surgery. In 2021 Daugherty received a seven-year \$5.6 million R35 grant from the National Heart, Lung, and Blood Institute (NHLBI) to study the tissues of the aorta and provide insight into how and why life-threatening thoracic aortic aneurysms and dissection occur.

Understanding the role of platelets



Sidney Whiteheart

A leader in the field of platelet biology, **Sidney "Wally" Whiteheart** (George Schwert Professorship in Biochemistry) is one of the few researchers in the world examining the capabilities of platelets at the cellular level. Platelets are small cell fragments that play a crucial role in preventing excessive bleeding after injury. When hyperactive, platelets can form a clot big enough to block an artery or vein, which can lead to strokes, heart attacks and deep vein thrombosis – some of the leading causes of death in Kentucky. In 2020, Whiteheart was awarded a prestigious \$6.6 million grant from the National Heart, Lung, and Blood Institute (NHLBI) as part of an Outstanding Investigator Award. His research also focuses on how platelets function during immune responses to the viruses that cause COVID-19 and HIV. Whiteheart was also part of a team of researchers studying how a type of antibody found in alpacas (nanobodies) could offer a solid defense against COVID-19 in humans.

Two researchers team up to help patients with heart failure

According to the Centers for Disease Control and Prevention (CDC), heart disease is the leading cause of death for Kentuckians. At the forefront of innovative approaches to help patients with heart failure are **Kenneth Campbell** (Dr. Thomas L. Skinner Professorship in Physiology) and **Jonathan Wenk** (Jack and Linda Gill Science and Engineering Professorship). A professor of physiology and cardiovascular medicine, Campbell's research bridges the scientific gaps between molecular, cellular and organ-level function. Wenk, who holds a joint appointment in mechanical and aerospace engineering in the Stanley and Karen Pigman College of Engineering and surgery in the College of Medicine, is applying engineering concepts to surgical approaches. With \$3 million in funding from the National Institutes of Health, Campbell and Wenk are working to make a direct impact on heart failure treatment. The team created a digital model of the heart that can be customized to individual patients and predict long-term results. Their computer software can predict how a patient's heart will grow over months and years with a genetic mutation or after taking a pill. The two are some of the first in the world to include inherited heart defects in their modeling. Campbell has also worked to create a biobank of samples of human myocardium (the middle layer of the heart wall) and a COVID-19-focused biobank to accelerate research on the virus.

SUBSTANCE USE DISORDERS

Research and treatment of substance use disorders

Kentucky is at the epicenter of the opioid crisis, and a team of researchers at the University of Kentucky is working to save

lives, achieve recovery and, ultimately, heal. As a health criminologist, **Carrie Oser** (Arts and Sciences DiSilvestro Professorship) is co-leading the Criminal Justice Intervention Team within the HEALing Communities Study. The \$87 million study is part of the National Institutes of Health HEAL (Helping to End Addiction Long-term) Initiative. Oser is the associate director of the Center for Health Equity Transformation and the Substance Use Priority Research Area, and a professor of sociology. Her research focuses on substance used disorder (SUD) treatment, health inequities, HIV risk behaviors and interventions, and social networks among a variety of populations. Oser has also provided congressional testimony and advised policymakers on best practices related to SUD treatment. She has been continuously funded by the National Institutes of Health for more than 15 years.

reach, the project targets 20 Kentucky counties with varying buprenorphine dispensing rates, with a goal to reduce barriers and increase buprenorphine accessibility to save lives.

Working to improve the lives of Kentuckians by finding new avenues of healing is **Chang-Guo Zhan** (Pharmaceutical Science Professorship and Research Endowment). Considered a visionary in the field, Zhan uses integrated computational-experimental studies to design and discover new drugs – either small molecules or engineered proteins. The work earned the College of Pharmacy's academic inventor the distinction as a fellow of the National Academy of Inventors. Zhan is also the director of both the Molecular Modeling and Biopharmaceutical Center and Chemoinformatics and Drug Design Core of the Center for Pharmaceutical Research and Innovation (CPRI). He led a clinical trial for a first-of-its-kind cocaine addiction therapy and has eight active research projects funded by the National Cancer Institute, National Institute on Drug Abuse, National Institute of General Medical Sciences, and Army Research Office.

The University of Kentucky College of Pharmacy is one of three institutions chosen by the Foundation for Opioid Response Efforts (FORE) to enhance medication access for opioid use disorder in healthcare settings. With nearly half a million dollars in funding, the college, led by **Patricia Rippetoe Freeman** (Earl Platt Slone Endowed Professorship in Pharmacy Practice and Science), aims to empower pharmacists in rural Appalachian communities to dispense buprenorphine, an FDA-approved medication for

Thomas Prisinzano (Kentucky Medical Services Foundation Chair in Pharmacy) is leading UK's Center for Pharmaceutical Research and Innovation (CPRI). The chair of the College of Pharmacy's Department of Pharmaceutical Sciences, Prisinzano's research combines the chemistry of medicinal and natural products. He's focused on the structure and function of neurotransmitter systems in the central nervous system and the development of medications to treat substance use disorder and pain – struggles well known to Kentuckians. Prisinzano also recently founded Rekovery Therapeutics, a startup company working toward a safe and effective therapy to address multiple sclerosis. He has five active research projects funded by the National Institutes of Health.


Reducing food insecurity



Alison Gustafson

Alison Gustafson (John I. and Patricia J. Buster Endowment Fund in Human Environmental Sciences), a professor in the Martin-Gatton College of Agriculture, Food and Environment, is focused on reducing food insecurity and improving diet-sensitive health outcomes across the Commonwealth. According to Feeding America, 1 in 8 Kentuckians face hunger, including 1 in 7 children. As director of the Food as

Health Alliance, Gustafson is creating valuable partnerships to facilitate food delivery programs. In March 2023, the White House announced the alliance is partnering with leading grocery technology company Instacart. The Grocery Prescription Program will provide participants \$50 each week to purchase eligible food items. Gustafson's team will measure clinical outcomes from this effort in food-insecure adults who are facing some of Kentucky's most pressing health challenges: Type 2 diabetes and heart disease.

A leader in the field of neuroimmunology

Linda Van Eldik (Dr. E. Vernon Smith and Eloise C. Smith Alzheimer's Research Chair Fund) is the director of the UK Sanders-Brown Center on Aging (SBCoA) and Alzheimer's Disease Center. She is the co-director of both the Neuroscience Research Priority Area and the Kentucky Neuroscience Institute.

Alzheimer's disease is a progressive and irreversible neurological disorder with no cure that affects thousands of Kentuckians. Researchers at SBCoA are making strides in the field, including the U.S. Food and Drug Administration's full approval of the first disease-modifying treatment for Alzheimer's in the U.S. – lecanemab – which was first studied at UK. A \$20.5 million grant from the National Institute on Aging (NIA) continues to fuel research and clinical initiatives on Alzheimer's disease and other forms of dementia at SBCoA. UK's Alzheimer's Disease Research Center is one of only 30 designated centers in the U.S. and has been continuously funded since 1985.

Van Eldik is a leader in the field of neuroimmunology, which focuses on the link between the immune system and the brain. She is the principal investigator on multiple awards, including one from the NIA to move work forward on a brain-penetrant, small molecule drug candidate developed by Van Eldik and her colleagues called MW189. In 2020, Van Eldik published results from the first human clinical study of MW189 that showed it suppresses disease-induced inflammation and brain injury.

Finding ways to extend quality of life

Gregory Jicha (Robert T. and Nyle Y. McCowan Chair in Alzheimer's Chair) is the director of clinical trials at the Sanders-Brown Center on Aging and played a critical role in the FDA's approval of lecanemab, marketed as Leqembi, for treating Alzheimer's disease. An antibody-based therapy, lecanemab targets amyloid plaques in the brain, a hallmark of Alzheimer's. This approval marks the first disease-modifying treatment for Alzheimer's in the U.S., with clinical trials showing a 27% to 40% slowing of the disease's progression. While not a cure, it extends the quality of life for those with early-stage Alzheimer's. Jicha's ongoing research emphasizes the potential for combination therapies and the importance of accessibility and affordability for widespread impact.

Spearheading a clinical trial on a new form of dementia

The work of **Peter Nelson** (R.C. Durr Foundation Chair in Alzheimer's Disease), director of neuropathology at the Sanders-Brown Center on Aging, focuses on combating neurological diseases, particularly Alzheimer's disease. He co-led a group of international researchers in discovering a new form of dementia named LATE, which affects cognition and daily life activities in an estimated 40% of people over the age of 85.

Nelson is spearheading the world's first clinical trial for LATE with colleagues here at UK. His contributions in the field have earned him recognition and made him a key figure internationally in the fight against Alzheimer's and dementia.

Leading a team of 30 scientists



Christopher Norris

Christopher Norris (Sylvia Mansbach Endowed Professorship and Chair in Alzheimer's Disease Research) leads a team of 30 scientists at the UK Sanders-Brown Center on Aging in first-of-their-kind research projects funded by a \$20.5 million grant for the National Institute on Aging (NIA) investigating the role of reactive astrocytes in neurologic disease progression and their potential to be therapeutic targets. Astrocytes, star-shaped cells found in the brain, play an important role in cell communication. Norris' team is looking for novel strategies to treat neurodegenerative conditions like Alzheimer's disease and other forms of dementia.



MATERIALS SCIENCE, MANUFACTURING

Guiding UK's new Materials Science Research Priority Area



John Balk

Guiding the University of Kentucky's new Materials Science Research Priority Area (RPA) is **John Balk** (W.T. Bryan Professorship in Materials Engineering). He is the associate dean for research and graduate studies in the Stanley and Karen Pigman College of Engineering and has served as director of UK's Electron Microscopy Center for 12 years. The RPA brings together a variety of experts at UK in an array of fields, from medicine and manufacturing to automotive

and aerospace applications, under one umbrella: Materials Science. Leveraging Kentucky's position to excel in this field – including the state's high concentration of metals (aluminum, steel) manufacturers and UK's scientific expertise in location, extraction and processing of rare earth elements and critical minerals (for everything from cell phones to satellites) – Balk is working with university and industry partners to provide solutions to unmet needs and position the Commonwealth to become a global leader in a competitive materials market.

A pioneer in organic materials



John Anthony

Shaping the field of materials chemistry is **John Anthony** (Charles W. Hammond Professorship in Chemistry). He serves as the associate director at the Center for Applied Energy Research (CAER) and has helped build a team of world-renowned scientists in this area. Anthony is a pioneer in organic materials – things that are made from carbon instead of silicon. His research focuses on organic solar cells, organic thin-film transistors and organic light-emitting diodes.

Those materials play a role in low-cost energy generation and high-efficiency lighting and are critical research components to the new Materials Science Research Priority Area. Anthony's award-winning contributions have made him one of UK's most highly cited researchers. He has secured funding through the National Science Foundation (NSF), National Renewable Energy Laboratory and National Institute of Standards and Technology. Anthony and fellow UK chemistry collaborator Chad Risko received an NSF Special Creativity Award to develop a first-of-its-kind computer model to predict the best combination of building blocks and processes to make organic semiconductors. This could make it faster and cheaper to use organic semiconductors in displays in televisions, tablets, smart phones and watches, the foundation of a multi-billion dollar per year industry.

Enhancing U.S. manufacturing capabilities

Led by **Ibrahim Jawahir** (James F. Hardymon Chair in Engineering - Manufacturing Systems), the University of Kentucky, in collaboration with the University of Tennessee, Knoxville, and the U.S. Army Combat Capabilities Development Command's Army Research Laboratory (DEVCOM ARL), launched a \$50 million, five-year partnership aimed at enhancing U.S. manufacturing capabilities. The UK-led project, "Next Generation Materials and Processing Technologies" (NextGen MatPro-Tech), received \$23.8 million. The collaboration will focus on four areas: engineered high-temperature materials, advanced additive manufacturing, novel manufacturing processes, and predictive modeling and performance assessment. Jawahir is also representing UK in a coalition of experts from academia, industry and state government that was awarded \$1 million from the National Science Foundation's Regional Innovation Engines (NSF Engines) program. With members from Kentucky and Tennessee, the Generate Advanced Manufacturing Excellence for Change (GAME Change) team will collaborate to create economic, societal and technological opportunities for the region. The work sets them up to pursue an NSF Engine Type-2 award of up to \$160 million, which would establish Kentucky, and UK, as a national leader in advanced manufacturing.

Bringing new approaches to engineering disciplines

Issam Harik (Raymond Civil Engineering Endowment Fund), and **Abheetha Peiris**, a researcher at the Kentucky Transportation Center, lead the CatStrong team at the Stanley and Karen Pigman College of Engineering. Together, they're developing sustainable solutions for deteriorating bridges by utilizing unconventional materials. Harik's students explored fiber-reinforced polymer (FRP) composites for construction, with human hair emerging as an unexpected ally. By transforming discarded hair into robust concrete construction forms, they enhance sustainability. The initiative not only strengthens bridges but also provides students with valuable experiential learning. Through CatStrong, the team pioneers eco-friendly techniques for structural enhancement, and this work is making waves in the field of civil engineering.

Yuming Zhang (James R. Boyd Professorship in Electrical Engineering) was named a 2023 Institute of Electrical and Electronics Engineers (IEEE) Fellow. This prestigious recognition highlights Zhang's contributions to research and teaching, particularly in robotized welding manufacturing through machine and vision-based intelligence in work funded by the National Science Foundation and industry partners. Zhang's work in intelligent robotic and human-robot collaborative welding systems has garnered him 12 U.S. patents and more than 200 peer-reviewed journal papers. With a history of leadership and recognition in multiple engineering societies, Zhang's commitment to advancing knowledge and societal impact was further recognized through his appointment as a University Research Professor for 2023-24.

Training the next generation of Kentucky students to pursue STEM careers

Hundreds of Lexington students have been introduced to potential careers in science, mathematics, engineering and technology (STEM) thanks to a program championed by **Luke Bradley** (Chellgren Center Endowed Chair). The UK STEM Through Authentic Research and Training (START) program introduces students early to careers in STEM by integrating academic, social and professional experiences. START works with UK colleges and local organizations to enhance the pipeline into college for first-generation and traditionally under-represented students. Since its launch during the COVID-19

pandemic, more than 1,200 students across Lexington school systems have had hands-on learning and training experiences in labs across UK's campus. The program is funded by a five-year, \$1.3 million Science Education Partnership Award (SEPA) from the National Institute of General Medical Sciences (NIGMS), part of the National Institutes of Health. Bradley is also acting chair of the Department of Neuroscience, where his research is dedicated to finding innovative molecular structures to detect, diagnose and treat diseases including Parkinson's.

GROWING UK'S RESEARCH PORTFOLIO

Endowment Match Program faculty have made substantial contributions to the University of Kentucky research portfolio. According to the 2022 report from the Association of University Technology Managers, UK ranks 51st in the number of startup companies formed among public universities and ranks 57th among public universities in total licensing income (\$1,523,917).

PATENT APPLICATIONS

In Fiscal Year 2022, UK filed 161 patent applications and five new startup companies affiliated with UK technology were formed.

FOCUS ON KENTUCKY

Research and development at UK has a direct, and significant, economic impact on Kentucky. The \$476.5 million UK spent on R&D in Fiscal Year 22 generated \$873 million in economic activity across the state. As a result, 4,636 jobs were supported throughout the state of Kentucky, with 2,227 (48%) of those jobs directly supported by research initiatives.

UK scientists and scholars among top 2% of world's most-cited researchers

The University of Kentucky is well-represented on a list of the most-cited researchers in the world. In a database compiled by Stanford University in a partnership with Elsevier, 140 current UK scientists and scholars appear among the top 2% of the most-cited researchers across 22 disciplines.

The data reported in this article is a snapshot of recent productivity. It includes only citations received during the calendar year 2022, hence it may not reflect career publications. Please see "About Elsevier's list" below for more information.

Citations are one measure of the impact of academic research. For researchers, publishing work in a peer-reviewed, scholarly journal is a key step in sharing research findings and new discoveries.

"Being cited is one sign that your work matters to the research community," said Lisa Cassis, Ph.D., UK vice president for research. "We acknowledge that citation metrics can have issues including gender bias and underrepresentation of community-focused and non-STEM research — the same issues with which the research community at-large is grappling. The University of Kentucky is dedicated to an inclusive culture of research across all spectrums of inquiry, and we value the contributions of all faculty, staff and student researchers. UK's world-recognized research is impacting the community and producing innovations that make Kentucky and the world healthier, wealthier and wiser. We congratulate these outstanding individuals for this citation recognition."

The database, updated October 2023 and available through the Elsevier Data Repository, was compiled by Stanford faculty member John P.A. Ioannidis. Database inclusion means the individual met a variety of metrics that place them among the top 2% of researchers based on citations for 2022.

In addition to appearing on Elsevier's list for 2022 citations, one UK faculty member — Sherali Zeadally, Ph.D., University of Kentucky Alumni Association Endowed Professor in the College of Communication and Information's School of Information Science and University Research Professor — also

appeared on Clarivate's Highly Cited Researchers list, which identifies scholars whose work has been cited most often in papers over the past decade. Those chosen for the 2023 list authored studies that rank in the top 1% in the number of scholarly citations worldwide within their disciplines. Zeadally has appeared on Clarivate's list for four consecutive years. Please see "About Clarivate's list" below for more information.

About Elsevier's list

Elsevier's single-year data, from which this list was derived, pertains to citations received during the calendar year 2022. Scientists are classified into 22 scientific fields and 174 sub-fields according to the standard Science-Metrix classification. The selection is based on the top 100,000 scientists by c-score (with and without self-citations) or a percentile rank of 2% or above in the sub-field. Calculations were performed using all Scopus author profiles as of October 1, 2023. If an author is not on the list, the composite indicator value was not high enough to appear. Using the most recent single-year data provides an up-to-date snapshot of productivity and expertise across 22 disciplines. This list does not include emeritus researchers, those who have left UK or are officially on leave. As of June 30, 2023, the University of Kentucky has appointed a total of 201 faculty endowed chairs and professorships under the auspices of the Endowment Match Program.

During Fiscal Year 2022-23, 91 endowments supported graduate fellowships. Since a single endowment may support multiple student awards, 372 graduate students received support from endowment proceeds.



IMPACT

Record-breaking Research Awards Power UK Innovation

For the first time in University of Kentucky history, investigators were awarded \$479.3 million in extramural grants and contracts to support their research in Fiscal Year 2023. This is a 5.8% increase from the \$452.9 million in Fiscal Year 2022 research awards.

UK researchers also made history in FY23 with a record 1,877 research awards to a record 837 principal investigators from a record 621 sponsors.

"Our continued growth as a research university is directly connected to the intentional focus we have on the biggest issues – cancer, cardiovascular disease, diabetes, neuroscience, substance use, energy and equity – and now opportunities with new national investment to expand the economy through advanced manufacturing and materials science. Without a question, research is vital in our mission to serve Kentucky," said UK President **Eli Capilouto**.

"Our people make our research possible. The principal investigators who lead our research teams work across academic boundaries to bring the best ideas to light. This growth is a testament to the creativity and innovation of the faculty, staff and students who make up our research investigator community at UK. Their tireless work continues to propel the university forward to advance our state and our nation," said Vice President for Research **Lisa Cassis**.

Industry-sponsored research awards grew by 9.6% from \$25.6 million in FY22 to \$28.1 million in FY23.

UK clinical research was supported by \$3.8 million from Eli Lilly and Company for the PRiMAL study, which examines the impact of review by a molecular tumor board – a team of medical experts who collaborate on treatment plans, looking at things like specific genetic tumor markers, to treat complex cancer cases. The five-year clinical trial, led by **Jill Kolesar**, Pharm.D., professor in the College of Pharmacy, will follow treatment and outcomes for 500 patients with advanced non-small cell lung cancer, the most common type of lung cancer. "Kentucky has the highest incidence of lung cancer in the nation," said **Mark Evers**, M.D., Markey Cancer Center director, "but our work including Dr. Kolesar's molecular tumor board – part of our individualized, precision medicine approach to patient care – is a model other cancer centers, across the country and internationally, are adopting to better care for cancer patients."

The Center for Applied Energy Research (CAER) and the U.S. Department of Energy's Oak Ridge National Laboratory are partners on a \$10 million project (\$1.9 million in FY23) to transform coal into high-value carbon fibers and composites. With construction, aerospace, automotive and defense applications, the market for carbon fibers is expected to grow at a compound annual growth rate of 12% through 2024. This is one of the leading-edge research fields related to UK's newly created Materials Science Research Priority Area.

Non-profit awards increased by 16.7% (\$22.3 million in FY22 to \$26 million in FY23). A \$3.3 million award from the Prichard Committee supports **Shannon Sampson**, Ph.D., assistant professor in the College of Education, who in partnership with the Kentucky Center for Statistics (KYSTATS), will serve in an external, independent evaluation capacity to support Full Service Community Schools. The goal is to improve the coordination, integration, accessibility and effectiveness of services for children and families in high-poverty schools across Kentucky.

Federal grants and contracts totaled \$252.6 million, accounting for 52.7% of UK's total awards in FY23.

A CATALYST FOR GROWTH

The Endowed Match program is a catalyst for the substantial growth in awarded external research funding to the University of Kentucky. Since the Kentucky General Assembly passed the Postsecondary Education Improvement Act of 1997 (House Bill 1), awards of external research grants and contracts at the University have increased from \$122 million to \$479.3 million (a 292.8% increase)
