# ACCEPTANCE OF INTERIM FINANCIAL REPORT FOR THE SIX MONTHS ENDED DECEMBER 31, 2014


<u>Recommendation</u>: that the Board of Trustees accept the University of Kentucky consolidated financial report for the six months ended December 31, 2014.

<u>Background</u>: The consolidated financial report includes the financial activities of the University of Kentucky and its affiliated corporations:

- University of Kentucky Research Foundation
- The Fund for Advancement of Education and Research in the University of Kentucky Medical Center
- University of Kentucky Gluck Equine Research Foundation, Inc.
- University of Kentucky Humanities Foundation, Inc.
- University of Kentucky Mining Engineering Foundation, Inc.
- University of Kentucky Center on Aging Foundation, Inc.
- Central Kentucky Management Services, Inc.

As of December 31, 2014, the University has recognized \$1,512,147,704 of current funds revenue representing 50 percent of the 2014-15 approved budget of \$3,016,665,100. Expenses and transfers total \$1,353,001,906 or 45 percent of the approved budget.
