	<p>The Interdisciplinary Arts Minor has not been updated in several years. As such, the requirements are out of date and include courses that are no longer offered at UK. Currently, there are only five students pursuing the minor. College of Fine Arts leadership believes that an updated minor would attract more students.</p> <p>The number of credit hours for the minor is being reduced from 24 to 18 which aligns the minor with the other minors in the college. This minor will allow for students to become more information consumers and patrons of the arts which will enrich their lives beyond graduation. This minor, unlike other CFA minors, will provide a broader understanding of the arts but not necessarily hands-on performance or arts creation experience.</p>

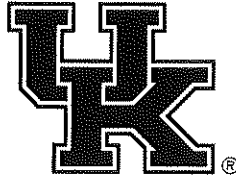

Interdisciplinary Arts - Minor

The Interdisciplinary Arts Minor allows students to design their own minor with coursework across at least two disciplines in the College of Fine Arts. The minor is intended to deepen an appreciation for and encourage a lifelong engagement in the arts.

To earn an Interdisciplinary Arts minor, students must complete a **minimum of 18-credit hours** of course work arranged as follows:

1. 6 credit hours of 100-level courses in a minimum of two CFA disciplines (AAD, A-E, A-H, A-S, ART, FA, MUC, MUP, MUS, TA, or TAD);
2. 6 credit hours of 200-level or above courses in a minimum of CFA two disciplines (AAD, A-E, A-H, A-S, ART, FA, MUC, MUP, MUS, TA, or TAD); and

Elective Courses

3. 6 credit hours of CFA courses at any level

Students pursuing a major within the College of Fine Arts must select courses *outside* of their major discipline.

Only three credit hours from courses taken to fulfill a requirement in another major or minor can be used to meet the requirements of the Interdisciplinary Arts minor.
