The certification program for all grades foreign language teachers is now administered in the College of Arts and Sciences through the Master's of Arts in Teaching World Languages (MATWL). The content area of the German Education major consisted almost entirely of Arts and Sciences coursework; the only Education class required was EDC 362, a course taken by all Secondary Education majors regardless of area. There has not been a faculty advisor for Foreign Language Education in the College of Education since Spring 2001; the SEGE major has had no active students or program completers since Spring 2006 (only one since Fall 2004).
