### **Course Description**

This course is a graduate-level investigation of several contemporary debates in the philosophy of perception. Among the questions we will consider are:

- What is the difference between perception and belief? Do experiences, like beliefs, have propositional content?
- What accounts for the distinctive 'feel' of perceptual experiences?
- What accounts for the differences between the senses?

In examining these questions and others, we will consider how philosophical debates about perception have been shaped by a focus on vision. In doing so, we will consider some of the other sensory modalities.

## **Required Readings**

Unfortunately, there is no quintessential textbook in the philosophy of perception. We will therefore have to rely on photocopies of papers/book chapters and online sources. Those that are not marked with an URL below will be available to you in the filing cabinet in POT 1406. Many of the readings are available online and I have provided some of the links to these below. I will provide the remainder of those available as the term progresses.

## **Reading Assignments**

There are reading assignments for each week. The readings will require close study, and you should not put them off until the last minute. This course is a **DISCUSSION COURSE**, and if it is to be of value to us, *your careful preparation of the readings is crucial*. With such a small group, it will be noticeable if we are not 'together' with the readings. If you have trouble understanding what an author says, or any other question concerning the course, please do not hesitate to ask.
